It is my pleasure to appoint Mr. Todd Pitman, Mr. David McCullough, Mr. Matthew Winter, Mr. Tim Hutter, Ms. Courtney Coyle, Ms. Carol Neidenberg, Ms. Amy Strider Harleman; as well as reappoint Mr. Richard Larimer, Dr. Ann Woods, and Mr. Michael Baksh to the Historical Resources Board.

Mr. Pitman is a landscape architect and community planner with a wide-range of experience. Over the past 20 years he has demonstrated extensive expertise in the fields of landscape architecture, campus planning, historic preservation, and construction management. Mr. Pitman is a Registered Landscape Architect in both California and Oregon and in addition to his certifications, he has acquired a Bachelor's Degree in Landscape and Design-Environmental Horticultural Science from California Polytechnic University.

Mr. McCullough is currently Principal Landscape Architect at McCullough Landscape Architecture, Inc. with nearly 17 years of experience. He also has experience with architecture, small businesses, construction industry and environmental services. Mr. McCullough is an active board member of the San Diego Architectural Foundation and the American Society of Landscape Architects.

Mr. Winter is an associate principal at BNIM Architects, a 2011 AIA National Architecture Firm Award winner. He has over 25 years of experience in the construction industry and has been in the field of architecture since 2000. Mr. Winter has been an active member of the community as a board member of the Uptown Planners, and on the Board of Directors of the Pacific Beach Town Council.

Mr. Hutter is an attorney at Allen Matkins LLP where he practices in the firm's litigation group. His primary focus is on business and real estate disputes, including contract, construction, joint venture, land-use and landlord/tenant litigation. Mr. Hutter has acquired a B.A. in political science from Yale University in addition to a J.D. from the UCLA School of Law in 2009.

Ms. Coyle is an attorney concentrating on Environmental, Historic Preservation, and Land-Use law, with a widespread history of experience in California Environmental Quality Act and National Environmental Policy regulations. She has worked to preserve Native American tribe's cultural heritage and historical resources. Ms. Coyle has been a devoted civic and

She has been able to unify her desire to help people with her passion for preserving historic properties including the preservation of a house from the 19<sup>th</sup> century in Memphis, Tennessee area. She eventually was able to establish this house as the first clubhouse program in the state for mentally ill adults.

Ms. Strider Harleman has represented Kearney Real Estate and its affiliates for nearly a decade. She also demonstrates an extensive knowledge of general contracting, finance, and planning. She is a member of the Greater Golden Hill Community Development Corporation as well as a former member of the Save Our Heritage Organisation.
