# uptown

Hopefully the attitude towards On-Site Preservation is beginning to change in San Diego. SOHO is working hand-in-hand with the Uptown Planners on a unique concept for On-Site Preservation in the Uptown area. The Uptown Planners are recommending a "Victorian Preserve" as part of the Uptown General Plan. The suggested preserve area would be bounded by Fifth Avenue and Maple Street and Freeway #5 (approximate boundaries). Within that area there are at least thirty special Victorian structures. Also within that area lies one completely empty city block (Morton Bay Fig lot). The Uptown Planners and SOHO envision the Morton Bay Fig lot as an In-City Preserve. The site is bounded by Fir and Grape Streets and Third and Fourth Avenues. There are seven Victorian structures directly related to the site.

We can foresee these structures remaining on-site and other buildings being moved to the vacant piece of land creating a unique-living preserve. Again we envision shops, boutiques, restaurants and perhaps living areas in the upper stories.

# downtown

From its inception SOHO has taken an active interest in the Horton Plaza Redevelopment Project. As the project was initially presented, every strucutre in the twelve block area would be destroyed in the creation of a new "revitalized south of Broadway." SOHO got involved in the project last summer and has been meeting with representatives of San Diegans, Inc. and the City Planning Department. It might be easiest to simply outline the structures we feel are valuable and their current status:

Horton Plaza and Fountain appear to be safe. Plaza Street will be closed and the Plaza area will be remodeled to its original 1910-20 state state.

<u>Pickwick Hotel</u> was slated to be destroyed; however, the owners are currently submitting plans for a handsomely revitalized hotel. The plans show the building actually restored to its original 1920's affect. It's an interesting example of early 20th century urban architecture.

Bradley's Bar faces the Plaza and is a handsome example of Spanish Revival architecture (if you take off the ugly signs). Land developers interested in the site on which Bradley's Bar is located will be encouraged to utilize the structure in their concepts.

Land Title Building along with the Spreckel Building forms sort of a triumphal arch. It is a good example of early 20th century "big city" architecture.

Spreckels Building has great historic significance for the history of San Diego and the possibility of saving it looks good. We hope that it will be declared an historic site. It has a quality of interior decoration which is not practiced today. It's certainly worth viewing.

Balboa Theatre is a unique example of Spanish Renaissance in San Diego. It's shocking to even imagine the domed splendor of this building tumbling down. It's now being considered for Historic Site designation and there's a good possibility that it can be preserved on site.

Horton Hotel is the most significant Victorian structure in the twelve block area. The hotel was built in the 1880's and has been well preserved up until this time. We urge you to walk down on "E" Street and go into the hotel. There's a skylight which floods the whole second floor and the stair well with natural light. The whole effect hauntingly beautiful. The exterior still displays the almost complete original concept. The wrought iron work is unique n in San Diego and is reminiscent of New Orleans Orleans.

There are other charming buildings in the twelve block area but we realize that they all can't be saved. Our feeling is that some <u>must</u> remain because not only are they beautiful to look at, they are of historic significance and they are architecturally unique. They are buildings that exist on a human scale. They are buildings you a can touch and feel. They reflect human qualities and they have personality.

We understand that the Redevelopment Proposal will come up for City Council consideration near the end of March. If you care, please write your councilman. Miles Parker

#### PARK PROPOSED FOR DOWNTOWN AREA

According to an article published recently in the In Diego Union, our City Staff is studying the momic feasibility of a downtown park (south of Broadway -- west of Fourth). Two blocks would be obtained from the New Town Park and the demolition of the old Federal Courthouse. Two more blocks could be acquired by a trade of City land. A seven-block park is proposed--the plan for obtaining the other three blocks was not explained in the article.

Plans are for a park patterened after Copenhagen's Tivoli Gardens. These gardens occupy a 20-block area and contains many restaurants, entertainment, benches, flowers and trees. The park is within walking distance of downtown and the land is leased from the City of Copenhagen. The park is administered by a private, non-profit organization. A similar plan is suggested for San Diego.

#### NATIONAL GROUPS TO MEET IN SAN DIEGO

Historic American Buildings Survey is sending a professor and three students to measure some of San Diego's historic buildings. There are some six houses to be measured but most of the time will be spent at the Hotel del Coronado. They will be here June, July and August.

#### FACE-LIFTING PLANNED FOR SHERMAN-GILBERT HOUSE



# PRESIDENT'S MESSAGE

"This building has less than two months before it will be torn down."

This was the famous message that greeted visitors to the Gilbert House during the early formative days of the Save Our Heritage Organisation. Since those fearful days of early 1969, much has happened. The house (now redignated Sherman-Gilbert House, in keeping with nominclature recommended by the Historic American Building Survey) is still there. The hospital, which was intended for the block where the Sherman-Gilbert House still stands, seems now not to be so eminent. And SOHO is \$7,000 richer than it was two years ago.

Is that the end? No. Even though it appears that the hospital will not be built on the site immediately, that or any one of a hundred speculative schemes might tempt the owner of the property to ask us to remove the house. The token rent being paid by the tenant of the house does not approach the potential return on investment of a prime piece of land so close to downtown.

At least the Victorian Square which we so enthusiastically campaigned for seems to have come about. The County Board of Supervisors put together a package that included some land trades with the City and private owners of property near Old Town to create San Diego's Heritage Park. The site is on the southwest corner at the foot of the Juan Street hill. The County Ordinance announces the formation of this site and specially designates it for Victorian-era structures. We are not certain when the area will be ready for development. We are not even certain that the Sherman-Gilbert House will be moved there; there has been no formal discussions between the new Heritage Park Board and SOHO.

SOHO could not have attracted the large membership that it has and maintained their interest, if we had not been involved in other related activities. You will read about these interests and functions throughout this Newsletter. The core of our interests has been the future of the Sherman-Gilbert House. There has been some informal discussions with members of other historical organisations concerning the possibility of acquiring yet another site closer to Uptown on which certain key Victorian structures might be moved. This would in no way lessen the importance of the County Heritage Park; to the contrary, it would probably strengthen it by having eventual depositories for a variety of architecturally significant buildings.

The past year has been economically unsettling in many areas of business. In a way, this has been a disguised blessing for the groups concerned with the retention of historic structures. Because of the business uncertainties, it appears that land speculation activities in the urban area cooled over the past year. Interest rates, costs of construction and the promise of a leveling off in general inflation may have caused many individuals to hold back in purchasing land for speculation. This has meant that fewer old structures fell under the wreckers ball during 1970 than in previous years. Now suddenly there is a change in the financial

world: interest rates are falling and the wages paid to construction workers may be controlled. This means that we must expect a return to to land-leveling activity which appalled us all during the late 1960's.

How to stop it? Probably the most realistic action is to support whatever legislation is proposed to the State Legislature. Attorneys are now studying the kinds of law which other states have in an attempt to write the most meaningful proposal to forward on to assemblymen and state senator's consideration. It will take time, but it is the most thorough way to thwart the hape of our historic buildings. In the meantime, perhaps individuals could be encouraged to write to their state representatives urging them to make the consideration of historic preservation through tax incentive among the most important decisions of the year.

As an alternative to the possible methods of saving Victorian structures mentioned before, there is another one -- physically moving the building. We in SOHO have proposed this for the Sherman-Gilbert house and others which may be threatened. Why shouldn't private individuals who are contemplating building a new home investigate the cost of moving a Victorian to their lot and upgrading it? In many cases, it may turn out to be cheaper than the cost of new construction. Certainly the final result will be more individual. If anyone questions the potential of Victorians once restored, spend a day in San Francisco.

The deterant, of course, is the stringent code requirement of moved buildings. If anyone is seriously contemplating buying a house with the intention of moving it, please get in contact with SOHO. Many of us feel that the labor-union inspired "make-work" laws found in current building codes deserve serious reinterpretation for specific imaginative building projects. While we are waiting for the laws which will permit and encourage owners to preserve buildings on their original sites, we may as well use the power of SOHO to investigate what the variations of the building codes are which will permit people to make use of existing structures in new locations. This is a whole new area for us but one which we feel is worth investigating.



Moving and Restoration: John Henderson, AIA, reports that an AIA committee has been established to do drawings necessary for placing the house on the site and also to get cost estimates from contractors. Members of the committee are Dale St. Dennis, Bill Tuell and Dean Wolfe.

#### JESSE SHEPARD MANSION

The second hearing for bids on the property was held on June 30th -- no other bidders were present and the house went to S. D. H. S. for \$26,000. Nine individuals (including SOHO and Historical Society members) loaned \$1000 each toward this purchase.

We feel particularly good about saving Jesse Shepard's house because SOHO was in the forefront and was instrumental in alerting the Historical Jociety and encouraging them to put up the banner. We are now on our way to real—preservation in San Diego and our Gilbert House is next.

#### MISCELLANEOUS

Jack Sarvella, Community Development, reports that the City Attorney's office is in the process of preparing the final draft of Historic Legislation. This legislation is actually an amendment to the current Historic Site Board legislation and is designed to give the Historic Site Board more authority. The HSB will furnish a listing of historic sites now designated -- the owner is notified that his property is an historic site -- when the owner applies for a permit to demolish or alter or move the house, there will be a period of time available to the Board to find means of stopping demolition and save the property.

The final form has been sent to the Historic Site Board and passed on to Uptown Planners to examine. Assuming no one has any changes, it goes to the City Council for review.

Sunday, June 17th, was the day of the Barber Shop opening (a SOHO benefit). Over 120 people toasted a painting of the Chapman & Smith barbershop at 327 Market Street. There was wine and a bread line (bread donated by lady SOHO members). The Cardinal Four (Hoover High's Barbershop Quartet) and Bryan Steager (Banjo Player) supplied music. Soho got newspaper and television coverage.

Earth Day - A SOHO member, Joan Jensen, coordinated the activites at Cal Western and SOHO participated by explaining our organization as an ecological movement. A mock-up of a Victorian House (constructed and painted by the teen group) was used at this event to help further explain what SOHO is about. #### CHAIRMAN'S STATEMENT

On June 11th and again on June 16th, SOHO and Historical Society representatives met with the City Council. From the outset, the Council seemed willing to listen to our plea. The members of the Council agreed that the Cherman-Gilbert House must be preserved. Their only concern was that perhaps the land at San Diego Avenue and Hortensia Street in Old Town was too small.

By the end of the June 16th conference, the Council directed the Historical Society to meet with the City Manager's office and resolve the dilemma. The joint recommendation of the Society and the City Manager's office will be accepted by the Council.
