#### ESTABLISHMENT OF AN ESTHETICS COMMITTEE

At the general meeting on August 27th, a new standing committee was established. Called the Esthetics Committee, this group will be responsible for evaluating privately owned buildings in San Diegø. It is intended that there will be an annual award given to owners of recently restored or repainted buildings in each of several categories: commercial, residential/ single family, residential/multiple family. SOHO feels that owners who enhance the appearance of their property beyond the perfunctory level of periodic painting ought to be singled out and commended. Few people could disagree when one considers what tri-tone paint did for the USIU Centre of Performing Arts at Third and Cedar; how much the Hotel San Diego is improved since its recent color coordinated repainting; how the imaginative re-use of a warehouse has made attractive architectual offices for Paul McKim & Associates at India and G. Streets; or how Al Ray has recently remodeled his house at Second and Upas into offices and living quarters.

The Esthetics Committee would like also to contact owners of neglected buildings and urge them to consider how much improved their property will be if repainted. Artists in SOHO will be available to suggest color combinations. The blend-into-the-background-beige look so much in vogue during the 1950's is no longer chic for all buildings. Architectual or carpentry detail no longer needs to be camoflauged.

### NATIONAL TRUST CONVENTION

More than 600 participants are expected for the 25th annual meeting and preservation conference to be held in San Diego on October 27 thru 31st at the Hotel del Coronado. The San Diego Historical Society is the host organization and local coordinator.

Save Our Heritage Organisation is organizing the Harbor Tours and the Victorian Tours. Barry Worthington is chairman of the tour committee. Harvey Pricer of the La Jolla Historical Society is coordinating the La Jolla tour. Other tours include Balboa Park buildings and the zoo, San Diego Historical Society and digs on Presidio Hill, the San Diego Mission and Cabrillo Monument and lighthouse. A fiesta in Old Town is being planned by the Junior League.

Lectures on California architecture and preservation will be held each day at the Hotel del Coronado. Floyd H. Hyde, Assistant Secretary of HUD for Community Development, will be the annual dinner speaker on October 30th.

#### THE HERITAGE PARK COMMISSION

When the County of San Diego acquired the five acre Heritage Park last year, they established by ordiance a commission to administer its operation. In addition to this responsibility, the Heritage Park Commission may also be charged with the designation of other historic properties elsewhere in the County. (The County may acquire other sites of historic interest -- for some years they have restored and maintained the Whaley House in Old Town.)

There are fifteen private citizens who sit on the Heritage Park Commission: two individuals named specifically by each of the five members of the County Board of Supervisors and five individuals who represent organizations in San Diego which have strong interests in the intrepation of San Diego's history. These fifteen people meet at least monthly to discuss the overall purpose of the Heritage Park, as well as to discuss specific problems that may arise in its operation.

At this time, the Commission's sub-committee on research and planning are establishing a master plan for the entire park. Because it is not possible to predict when an historic or architectually valuable Victorianera house may become available, the research committee is preparing an informal list of structures in San Diego which may fit well into the total plan for the Park. If one of those buildings is threatened, such as the Sherman-Gilbert House was in 1969, the Commission as a body will initiate action to acquire the structure.

The Heritage Park Commission does not have funds to make a house-move. They have three broad methods to bring structures onto Heritage Park:

- (1) They have the option of recommending to the County Board of Supervisors that public money be used to move a structure (a precedent which the Supervisors did not want to begin, you may recall, when the Sherman-Gilbert House was moved)
- (2) That a private group or organization take the responsibility of moving the structure, such as SOHO did.
- (3) That the Commission itself act as a fund-raising body and attempt to generate funds to move a desired building themselves.

There is great flexibility within this Commission, and they are not restricted by complicated bureaucracy. They are responsible directly to the Supervisors. The particular make-up of members on this first Heritage Park Commission insures that action will be taken.

Relations between SOHO and the Commission have been amicable since the inception of the Commission earlier this year. If SOHO is called upon to assist any organization with details of moving a Victorian structure to Heritage Park, full cooperation from the Commission is expected.
