ONE YEAR AFTER

The anniversary of our moving the Sherman-Gilbert House is a time for us to consider what has been accomplished in the past year. The house is still setting on a temporary foundation but we expected that it would be for approximately a year and a half.

The Heritage Park Commission has completed a site plan that includes twelve to thirteen structures. All of these structures will not be houses. They hope to have a mansion as the center focal point, a row of commercial shops and perhaps a firehouse or school-house to complete the Victorian Preserve.

The County Park Development Department is working on site development. They are installing utility lines and plantings on the site. The site should show considerable improvement within six months.

Dick Yale is heading a Research Committee made up of college students. Lucy Killea and Helen Ferris are assit assisting Mr. Yale.

There is a possibility that the permanent foundation will be constructed and the Sherman-Gilbert House will be moved onto it in the near future. Our members and friends will be notified of any progress made in restoring the Sherman-Gilbert House.

We understand that Mayor Pete Wilson has written to the President of Santa Fe Industries, Mr. John S. Reed, urging that the depot be preserved.



The City Council, sitting as the City's Redevelopment Agency, will hold a public hearing at 2 p.m. June 20th on the proposed Plaza Redevelopment Project.

The ambitious project to give a facelifting to 15 blocks south of Broadway at a cost estimated as high as \$150 million won the approval Wednesday of the City Planning Commission. The vote was 5 to 1. (reprinted from the San Diego Union May 19th, 1972)


A limited edition of individually colored lithographs were offered for \$35. Black and white lithographs are \$5.

LEGISLATIVE PROCEEDINGS

Although SOHO is not in any way a politically oriented organization, we of the Board would like to remind members and readers of this newsletter that among the candidates for reelection in an upcoming supervisoral race is a person who helped us to realize our goal, the Victorian Preserve. Jack Walsh began the plans for Heritage Park in the summer of 1969 when SOHO was still in its infancy. Working quietly with representatives of the many agencies and organizations involved in the acquisition of the Park land. Jack spearheaded the campaign that later materialized as Heritage Park. He and former Supervisor DeGraf Austin set up the pattern for the administration of the Park ... a committee of active citizens whose actions of the past year indicate that the Park is destined to be first rate in historic interpretation.

When the Sherman-Gilbert House needed to be moved and SOHO was still short some of the funds to pay for that move, Jack Walsh recommended to his fellow Supervisors that the County make the unprecedented effort of lending money to a private foundation. With this loan of \$5000, SOHO was able to pay for the move. The first installment of the repayment of this loan will be met by SOHO in June.

Jack Walsh had enough faith in us and in our vision of a Victorian Preserve to put his political life out on a limb to back our plans. I think that we of SOHO owe him a great deal and that we should enthusiastically support him in his reelection.
