




#### **Volunteers**


### **Redlining Attacked!**

A new state agency promises to renew the drive against redlining, the practice by some lenders and government agencies of withholding financing in specific geographical areas without regard to the worth of the would-be property owners. The new Housing Finance Agency will make direct mortgage loans to finance low and moderate income housing. The agency is expected to issue \$200 million in revenue bonds later this year and to submit \$500 million in general obligation bonds for voter approval in November 1976. A spokesman for the California Association of Realtors welcomed the program, but said that counselling of potential home owners would be required to make it a success. According to Richard Farrer, president of the 80,000 member organization, families need to know how they can inexpensively renovate older structures. Farrer also contends that cities must be pressured to provide equal services in redlined areas, including capital improvements, police protection, and trash pick-up.

#### Old Town: A Hit

San Diego's Old Town outdistanced Sea World and the Zoo as a visitor drawing card in September. Almost a quarter of a million tourists visited the historic area which includes Heritage Park. The figure represents an increase of 82 percent over the same month a year ago.

The surge in attendance has been paced by the growth in visitor oriented commercial establishments which have located in the district, many of which have renovated older structures. All construction in the area is guided by a design review board which seeks to maintain the district's unique scale and character.



#### **Demolished**

TACOMA, WASH. Gregory Mattson said he was never notified by any government agency that a house he had bought was condemned and scheduled to be demolished. So when Mattson thought he was investing in fix-up property, he didn't realize he would have to fix up a vacant lot. Mattson discovered his house had been demolished from a neighbor who had watched the bulldozers do their duty. Mattson said he thought the neighbor was kidding. But demolition crews were acting on a very real condemnation order from the Tacoma Building Department, orders Mattson said he knew nothing about. The federal Department of Housing and Urban Development knew about the order even before it sold the home to Mattson, an official said. had a notice of abatement proceedings on file in November 1973 when the house was sold," said John Valley. HUD's acting director of property disposition in Seattle. But HUD neglected to tell Tacoma the house had been sold to Mattson. "We can't take the time to do these things for every house we sell, " said Valley. "We feel the buyers should make some kind of inquiry to the property city departments." Ben Thompson of Tacoma's Building Department said he never learned HUD had sold the house. "We kept sending them notice after notice by certified mail, but we never received any reply," he said. Meanwhile at HUD, the notices were being dutifully filed away.
