

### WITHERING HEIGHTS?

Golden Hills, one of the City's last untouched preserves of Turn-of-the-Century structures, has become the site of quiet deliberations on the fate of future development. Granted authority last year to work with city planners in devising a neighborhood growth strategy, the Golden Hills Precise Planning Organization has taken the first steps towards recognizing and preserving the area's rich architectural heritage.

The Golden Hills Planners have every reason to be optimistic about the eventual outcome of their efforts. Bruce Dammann, a noted architect who has rehabilitated a large bungalow built by the Scripps family, chairs the group's urban design subcommittee. Dammann has brought professional design know-how and contagious energy to group's deliberations.

Another strong base of support has been the area's large minority and low-income population. At first suspicious of the preservationists—on grounds they were elitists who placed structural over social values—minority representatives on the group's executive board now appear convinced that saving the existing housing stock is one of the most realistic alternatives to the potential encroachment of expensive and exclusive high rise development.

Both factions recently co-authored a bid to the City Council for community development block grant funding of a comprehensive preservation program which

would allow low-income property owners to upgrade their structures.

Lest false optimism prevail, the City bureaucracy is still pondering the fate of money for Golden Hills and the planning group itself is frought with uncertainty over ways to devise a program of developmental regulations and incentives in keeping with the area's unique architectural environment. A hoped-for deadline for completion of the precise plan has been set for early next year, meanwhile Golden Hills residents who are interested in the planning process are encouraged to contact the City Planning Department, 202 C Street, for further details.

### **Recycled Era**

The following are excerpts from a recent article in the S.D. Daily Transcript by Denise A. Carabet:

Los Altos - When a savings and loan with an "out-of-town" name, like San Diego Federal, makes a break into a Northern California market, like Los Altos, how does it go about endearing those residents to it?

By purchasing its circa 1913 train depot, refurbishing it to bygone grandeur and then throwing a party for the leading citizens, all potential depositors--but with discreet good taste.

Between munches of fresh fruit and cheese, Los Altos' former mayor confided, "It's wonderful that the savings and loan did this. The city sure didn't have the money to put into the depot."

The bungalow-type commuter station and two cars--one caboose and one exquisite old parlor car with sculptured ceiling--was brimming with Los Altos citizens, San Diego Federal personnel, media and even a Federal Home Loan Bank representative or two, at Thursday's welcoming party. The S&L branch opened for business last Monday.

Los Altos residents, who could very accurately be compared with La Jolla residents, delighted in relating tales about the old station, and nostalgically outlined trips taken from the one-time commuter port.

San Diego Federal's architects built a porch-like front on the building, although originally the only ornamentation was on the track side, not the street. Cream colored walls and unfinished beams still dominate the room, and tellers peer through old brass wire mesh ticket cages at customers who tred on Chinese red carpeting. In the waiting area, the floorboards are rough and unfinished. Behind the manager's imposing antique desk is a storeroom marked "baggage."

The caboose will also be used for branch storage, but the parlour car will be given over to the community for a meeting place.

## NEWS FLASH!

LABOR UNION PLANS DESTRUCTION OF MANSION

Lending immediacy to the preservation concerns of Golden Hill residents is the impending demolition of the noted Patrick Martin house at 25th & E Streets. A spokesperson for the Shipwright and Boat Builders Local 1300, AFL-CIO says the Union is cramped for space at its present headquarters and "the bull-dozers would be at work tomorrow" at


the Martin site if not for financial commitments the Union has made in connection with a shipyard strike. Current plans call for demolition of the house in less than a year and the construction of a concrete block Union Hall on the property.

Members of the community have complained that the Union has been unresponsive to their please for preservation and re-use of the structure, but efforts are in progress to arrange further discussion of the issue.

### Thumbnail Tour:

GOLDEN HILLS

Golden Hills is a predominantly residential neighborhood on the southeast border of Balboa Park. Three styles of housing representing approximately 30 years of developmental history are found. Begin the tour at the corner of 20th and Broadway and notice a number of small Victorian houses as well as an Oriental pattern bungalow. Move east along Broadway to 23rd St., and the Haywood-Patterson house, a city historical landmark now being exhaustively renovated by a private party.






At 24th, find the Quartermass-Wilde house, another historic site built in 1896. Down the street at 2456 Broadway is the Frost house, Irving Gill's first design project in San Diego. Throughout this neighborhood are examples of large mansions circa 1895, at least one of which is in danger of destruction.

777 20th STEET 20th & Broadway

Proceed north and east through the community to the area of 28th Street and the Park. Many of San Diego's finest bungalows are located here, and the noted "Craftsman" style popular at the turn of the century is clearly apparent.
