

Election Meeting

It's also time to vote on the Office Committee's recommendation for a headquarters location and changes in our Bylaws (for details, see the reports of the Nominating and Office Committees in this issue). This could be one of SOHO's most important meetings. Don't miss it!

The meeting will be held in the quarters of the San Diego Ballet on the upper floor of the old IOOF building at Sixth and Market in the Gaslamp Quarter (526 Market St.) at 2 P.M., Sunday, September 11. As usual, cookie bakers will be welcomed with open arms.

It is difficult for me to believe that the year has passed by so quickly. Much has been accomplished, yet I know there is so much more to do. Before I leave this office it seems appropriate to recall the past year's achievements and express

some hopes for the future.

Our tour guides and hostesses have been very busy since September '76. A tour of historic Coronado was a tremendous success last Fall, and we also provided many tour guides for the AIA convention this past Spring. As for social events, the Christmas party at the Livingston house and the membership reception at the Quartermass/Wilde house were among the most enjoyable evenings in SOHO history. General meetings at the San Diego Rowing Club, La Jolla Women's Club and the Granger Music Hall were also interesting affairs.

One of SOHO's most important contributions to the cause of preservation in San Diego this year has been our rapidly expanding technical library. This is a collection of material dealing with specific preservation problems, and providing "how to do" and "where to find" information for persons interested in restoring early buildings. If you would like to donate designated funds or relevant resource material to the SOHO Preservation Library, please contact Pat Schaelchlin, Librarian.

San Diego's preservation scene has witnessed a number of exciting changes recently. In Heritage Park, the Bushyhead, Christian and Burton houses have now been completely restored on the exterior. When the tenant leases are signed, the interior restoration will get underway and should be completed by next year. SOHO's dream of nearly ten years ago is now a reality.

With the designation of the Gaslamp Quarter as San Diego's first historic district, a revitalization of the area should result. Already a number of buildings are being refurbished, notably the Yuma building, Grand Pacific Hotel and of course the Spaghetti Factory and Francis Family Antiques. I am confident that others will follow their fine example.

SOHO's biggest preservation victory this year was saving Horton Plaza from being paved, and convincing the City to restore the area to its former condition. Years of neglect created an eyesore of the once-beautiful Plaza until it reached a state of such dilapidation that the City was ready to "temporarily" pave it over to the tune of \$60,000. SOHO thought that the money could be better spent in restoration and launched a massive campaign to stop the proposed destruction. Our tremendous success (the City Council voted to spend \$100,000 to restore the Plaza to our specifications) proves that the old saying "You can't fight city hall" is not always true. Most important, however, is the fact that after over five years of "redevelopment", this is the first positive step the City has taken toward revitalization of the south of Broadway area. Restorahas already begun and should be finished by the end of the year. SOHO SAVES!!

And so what's next? Major preservation efforts are still needed downtown. The Gaslamp is on its feet, but the program needs guidance and coordination. The Knights of Pythias Castle is undergoing restoration, but what's to become of the Balboa Theatre and Grand-Horton Hotel? Other historic neighborhoods such as Golden Hill need our help as well, and what does the future hold in store for the Long/Waterman, Britt/Scripps and Melville Klauber houses? These structures are of basic cultural significance to San Diego and must be saved. Will our descendants praise us for being farsighted. or condemn us as the vandals of their heritage? We must make the choice now.

At our election meeting last year, I made the promise that before my term was over the Save Our Heritage Organisation would have a headquarters. This may be cutting things a little close, but it now looks as if I can keep that pledge to SOHO. Our office committee has found an exciting location in the Gaslamp that I think will be an excellent choice for headquarters. Those members who are able to attend the election meeting will have an opportunity to inspect the office and vote on its acceptance. SOHO may soon have a home!

The nominating committee has selected a fine slate of officers and board members for next year. Due to the increased activities of our organization, they have decided to expand the board to fifteen members with three alternates, and also revise the list of officers. These changes will require alterations in our Constitution and Bylaws which must be approved by vote of the general member-

NOMINATING COMMITTEE RECOMMENDATIONS SOHO BOARD OF DIRECTORS 1977-1978

The Nominating Committee recommends to the membership of the Save Our Heritage Organisation that the Board of Directors be expanded from eleven members to fifteen members to accomodate the increased activities of our growing organization. This Committee also recommends that the list of officers be updated to allow for an expanded executive board. The new offices created would be: xecutive Vice-President (to fill in for resident when necessary, and to coordinate the various committee activities), Vice-President for Education (to be responsible for tours, slide lectures, displays, etc.), and Vice-President for Governmental Affairs (to keep track of preservation legislation and also public hearings where SOHO should have a representative).

These nominations are all pending approval of Constitution and Bylaws changes to be presented at the election meeting

September 11.

He has also been a very active SOHO member working on many events as well as being chairman of SOHO's Office Committee. 


It all sounded so easy a year ago-"find a home for SOHO!" After all, we
had money. All we needed was a fantastic,
significant piece of architecture that we
could turn into our office! A lot easier
said than done.

The office committee put together a list of minimum requirements and decided that we would need a house at least the size and quality of the Long-Waterman House or the Melville Klauber Residence. Quickly we came back down to earth and reevaluated our priorities. We had hope of acquiring the carriage house of the Long-Waterman estate and of buying the Follies Theater next to the Yuma Building in the Gaslamp Quarter. Unfortunately, neither of these offers were accepted. We scoured the Golden Hill area and other areas in San Diego in search of a suitable house at an affordable price, but so far none have been available. Our search continues for an investment that would give SOHO all the qualities we need for our final office location.

Why The IOOF Building?

Built in 1882 in the heart of the first business district, the IOOF building housed the Masonic Lodge No. 35 and the Odd Fellows Lodge No. 153. Today the second floor is the home of the San Diego Ballet--their space restored and decorated

to former elegance.

The building sits within a historic important area that has as neighbors the McGurk Block (Ferris and Ferris Drugs) and the newly renovated Yuma Building housing the architectural firm of Macy, lenderson and Cole. Neighborhood revitilization is taking place--SOHO can be a leading force in influencing others to locate in the area.

The owner of the IOOF Building, Mr. Charles Tyson, has made a commitment to restoration and rehabilitation by his involvement in O'Sullivan Square, the Chinese Congregational Church and Lodging House, and other older buildings that have found a new lease on life by adaptive reuse. Mr. Tyson is also cochairman of the Gaslamp Implementation Task Force.

Plans For Our Space

The corner location provides SOHO with high visibility to multitude of vehicular traffic on Market Street. A short walk from the Spaghetti Factory and Francis Family Antiques, our office could prove to be a draw to getting more pedestrian traffic into the Quarter.

The 600 square feet of space allows us space for our administrative office duties, a library area, and a sales and display area. An added bonus is use of the basement for storage of all the artifacts SOHO has collected over the years.

We will be involved with painting, floor refinishing and design work that will give us a sense of pride and feeling of achievement. It's a chance to get members together for "work-parties" and to become a visual statement to the community that SOHO does SAVE!

The one year lease with a one year option allows us to organize our volunteers, get our library out where the members and public can use it for reference, and give us a meeting space with the possibility of using the Ballet facilities for larger meetings, seminars and workshops.

More details will be discussed at the General Meeting. Your input and work is necessary for the success of this venture.



THE NEW SPIRIT OF THE GRAND PACIFIC by Cathy Grigsby

As in a scene out of MAMA KNOWS BEST we sat around the kitchen table—a cozy light glowing overhead. Tenants knocked on the kitchen door to ask for a new supply of soap, discuss the latest television program or just to engage in friendly chitchat.


A year ago the scene was not so pleasant. When Shirley Bernard first purchased the Grand Pacific Hotel in the fall of 1976, the atmosphere was intimidating to tenants and visitors. Bars on the manager's window greeted guests. Tenants viewed each other with fear and suspicion. As in many situations where the landlord is absent, the Grand Pacific's ninety year old grandeur was hidden beneath dirt and neglect. When Ms. Bernard spotted the hotel last summer, it was operating as a two dollar a night flop house.

Shirley Bernard could visualize the building's basic charm beneath its dilapidation. Its location on lower Fifth Avenue of the Gaslamp Quarter seemed promising; the hotel's neighbors also showed the unique architecture characteristic of San Diego's boomtime 1880's. In a building which had seen no improvement in twenty years, the new landlady began room-by-room renovation.

Now almost all of the thirty-one rooms have been painted, draped and recarpeted at approximately \$175.00 per room (obviously much lower than if done professionally). Although new lights and plumbing fixtures have been installed, no major rewiring or plumbing has been necessary. As part of the first phase of the hotel's renovation, its exterior has been painted brown with a white trim. Ms. Bernard plans to have trees planted and awnings installed by late fall. She is

stripping and refinishing the hotel's oak railings and wooden doors. The hallways are beginning to take on a nostalgic elegance with their white walls, antique floral pattern carpeting and old light fixtures. The interior is being furnished with some of the antiques Ms. Bernard discovered in the hotel.

Along with the physical changes taking place in the hotel, the attitude of the hotel's occupants has also changed. Tenants show a healthy cross-section of ages and income sources, such as Social Security, Veterans Benefits, Unemployment Insurance and various pensions.



According to Ms. Bernard, the feelings of intimidation and isolation lasted about one week after she bought the hotel. Now a neighborly feeling of mutual concern and friendliness pervades the Grand Pacific. Although tenants respect their neighbors' privacy, there is evident awareness of each others' well-being--such as noting a prolonged absence.

In a hotel where a dorm room bed rented for two dollars a night last year, rooms are now being rented for \$56.00 to \$80.00 a month. There is a waiting list for vacancies.

Thanks to the spirit and vision of the Grand Pacific's new owner, another grand Victorian will live to lend its grace to the Gaslamp Quarter.

Here is a unique opportunity to explore some of the hidden resources of Balboa Park and to enhance your know-ledge and enjoyment of one of the most beautiful urban parks in the world.

Citizens Coordinate, in conjunction with the California Council for the Humanities in Public Policy, is sponsoring a conference on the history and future development of Balboa Park, October 7 and 8, 1977. One important aspect of the conference will be a guided bus and walking tour of all sections of the Park, including Morley Field, Golden Hill, and the U.S. Naval Hospital grounds, as well as the more familiar El Prado area. The tour will take place Friday, October 7.
