The TROLLEY BARN, located at the west end of Adams Avenue and for years known as the San Diego Paper Box Factory, is a 67 year old red brick Electric Railway building reminiscent of the days when the streets of San Diego rattled with trolleys. Trolley barns such as this have been successfully preserved and converted into colorful commercial ventures like Ghirardelli Square in San Francisco and the Trolley Barn in Salt Lake City.

## The Trolley Barn was part of the 1913 development inspired by San Diego magnate, John D. Spreckels. Other vintage buildings hailing from that epoch include the 1915 Panama California exposition, the Spreckels Theater Building, and the Golden West Hotel.

# FAREWELL, TROLLEY BARN...

"The structure (of the trolley barn) is a prominent and highly visible landmark in the area by its sheer size and location. Vistas of Mission Valley are caught through the parking lot and the canyon beyond, giving the viewer some sense of location."

But the above facts and statement were omitted from the historic report submitted in the defense of the old Trolley Barn. Now it is destined for a different fate. Local developer, Hooper-Goode Inc., is planning to level the barn and build a 96-unit condominium project.

George Szabo, an architect working for Hooper-Goode Inc., hired an environmental consulting firm, Advanced Planning & Research, to write a full-scale environmental impact report. The original report was prepared by historic preservationists and ex-SOHO presidents, Marc Tarasuck and Patricia Schaelchlin.

Szabo later conceded that he recommended changing certain segments of the historic report. Craig Lorenz, an Advanced Planning and Research analyst, who edited the report considered the alterations insignificant. However, when the deletions were brought to the attention of Tarasuck and Schaelchlin, they believed the alterations biased the argument against the old trolley barn.

Szabo later hired University of San Diego historian Ray Brandes to prepare a second report. Brandes concluded that the trolley barn was not historically significant.

City officials make land use decisions based on reports submitted by developers. The entire incidence raises questions about the validity of reports submitted by developers who have a vested interest in the decision. It is not unlikely that the individual who not only must pay for the land but also must pay for the report would select a consultant sympathetic to his needs and wants.

But citizens and future generations of citizens also have the right to look back on the history and development of their city as it is manifested in the character of the buildings around them.

the best of all possible worlds there would be a neutral, city historian or board of historians who could make wise decisions about just exactly what constituted history. Then there would be unbiased reports submitted to city officials and decisions would be clear.

But alas, there is no city money for such historians, and reports are somehow edited and, in the final analysis, many developers see their future and ours in dense living structures.

#### LAND CONSERVATION AND PRESERVATION TECHNIQUES

Federal income tax laws encourage charitable contributions by allowing a deduction equal, with some exceptions, to the value of the donation. There are many ways of putting this "tax incentive method" of heritage preservation to work.

Did you know that ....

...an individual may donate property to a donee organization but retain possession and use of the property for his own lifetime and/or the lifetime of his family. When such a gift is made the donor is entitled to a present income tax deduction.


.. the donor of a qualifying conservation easement to a public agency or qualifying charitable organization is entitled to a deduction for the fair market value of the easement.

...a landowner who leases to a public agency or charitable organization (where the land is used for public purposes) may be entitled to a tax exemption.

...a "bargain sale" to a qualified organization provides the landowner with some actual cash as well as a capital gain tax reduction, total avoidance of brokerage fees, and a charitable contribution deduction.

..a deduction for charitable contribution may be obtained when a landowner fully donates or bargain sells his land and then leases it back.
