# Art, Architecture & Music Combine in 'Footbridges to Fortune' Tour'

Art and architecture are the hall-marks by which civilizations are judged. Yet they are also the very personal expression of the person who creates them. On Saturday, Oct. 22, 1983, the public can enjoy both media during a walking tour and party in San Diego's Banker's Hill area.

The influence of Irving Gill is predominant in the area, with many Gill-designed houses as well as residences by his nephew Louis Gill, his partner W.S. Hebbard, and his proteges Emmor Brooke Weaver, Hazel Waterman, Richard Requa, and Frank Mead.

Halfway through the tour, the tour groups will converge for a 45-minute party and rest stop. On display will be original drawings and prints of the five open houses and one garden, each drawn by a different artist. Although the artists represent a cross section of personalities and background, they are all specialists in setting historic buildings to paper. Inexpensive prints will be for sale along with related works of the artists. Party guests will also be able to bid on the original drawings in a silent auction.

The featured artists are Robert Miles Parker (The Coulter House, 1916, Carleton Winslow, Sr.); Robert Hostick (The Charles W. Fox House, 1908, William Sterling Hebbard); Carol Lindemulder (The Charles F. O'Neall House, 1912, Emmor Brooke Weaver); Eldon C. Anderson (The Randy Prine House, 1920); Matt Potter (The Colonel Ackerman Gardens, 1912, Hazel Waterman); and Susan Simmen House, 1908, the Schaniel Brothers).

Robert Miles Parker founded SOHO in 1969 in an effort to save the Sherman-Gilbert House from destruction. The house was eventually transplanted, becoming the initial structure at the Victorian preserve in Heritage Park. In 1974, Parker embarked on a three-year odyssey across America to capture the country's architectural "soul." His efforts were recorded in a book of drawings, "Images of America." Parker is now working on a new book, "Outrageous Los Angeles," due out in time for the 1984 Olympics.

Robert Hostick, the artist of the grand finale party site, is both a graphic artist and an architectural designer. He and his wife Daun Martin are probably best known to local preservationists for renovating the Britt-Scripps Townhouse at Fourth and Maple as a bed and breakfast inn. In 1968, Hostick drew an artist's conception of the downtown Gaslamp Quarter for San Diego Magazine. His printed sketches preceded renovation projects in the area by 10 years.

<u>Carol Lindemulder</u> is one of the original founders of SOHO and later was its president for three terms. In 1981, she assumed the presidency of the "Save the Coaster Committee" to preserve the Belmont Park roller coaster. A native San Diegan, Lindemulder has been exhibiting paintings

and drawings professionally since 1963. She owns her own interior design firm, "Call Carol."

Eldon C. Anderson has lived, traveled, and worked in many parts of the world as a Marine Corps paratrooper, airborne unit commander, and advisor to the Royal Thai Army. Anderson was a member of the San Diego Cultural Heritage Committee, the County Parks Advisory Committee (where he represented Heritage Park interests), and the Board of Directors of the San Diego Art Institute. He is presently a member of SOHO, the La Jolla Art Association, and the Board of Directors of the Committee of 100 (Balboa Park's architectural preservationist group).



Excerpts from an article by Arthur Ribbel in the Sunday Union August 14th:

It is recorded that the San Diego City Guard Band was organized in 1882, and that its first appearances in public were at the exhibition of agricultural products in Armory Hall. In 1887 it was proposed, with City Council approval, that the band be sent East as a booster advertisement for little San Diego, which then was trying to woo more settlers to its shores.

# God Old Days'in Banker's Hill &

You can find out how your rich great uncle might have lived at the turn-of-the-century. The years before World War I will be re-created with the houses, cars, fashions, and music from that era during a walking tour and party in Banker's Hill, which borders the west side of Balboa Park. Mark October 22 on your calendar, and get your reservation in soon.


Five houses and one garden will be open for viewing during three-hour walking tours starting at 9 a.m. and 1 p.m. The open houses, which range from 1908 through 1920, are prime examples of the roots of modern archi-

tectural design.

The activity will begin at Sixth and Redwood in Balboa Park where small groups will be led on a three-mile route through an area that is a well-preserved time capsule of architecture from the era immediately preceding World War I. For example, one particular block on the tour route encompasses houses by William Sterling Hebbard, Richard Requa, and William Templeton Johnson sitting side by side. About 45 structures will be covered on the route.

The party will feature a morning concert by the 50-member City Guard Band, an afternoon concert by the 40-member Sun Harbor (barbershop) Chorus, an art show featuring six prominent local artists, displays of antique cars from the Horseless Carriage Club of America, an old fashioned hot dog vendor, and a Country Store with craft items.

Admission to the party and tour is \$10 if received prior to September 22; \$12.50 after that date. Your check is your reservation and all checks are due by October 14. Send to SOHO, Dept. 00, P.O. Involved in the growth and changes of Heritage Park since its inception, Anderson has accumulated a valuable record of park history through photos

and drawings.

BAND (Continued)

On the night of September 1, 1887, the San Diego City Guard Band of 21 players clad in resplendent new uniforms, left the depot in a private car for a tour of the Country. It was a high time of glory and fame for San Diego's City Guard Band.

And now, in the 1980's, comes the SAN DIEGO HERITAGE CITY GUARD BAND, formed in 1980 by George Wheeler, a bass horn player. The band has already played at major functions in the "Finest City." With headquarters at Recital Hall in Balboa Park, it is preserving the 'glory and fame' of San Diego's City Guard Band of the 1880's.

THE CALIFORNIA HERITAGE TASK FORCE, A PRIVATE/PUBLIC PARTNERSHIP, VISITS CALIFORNIA'S OLDEST CITY

On Friday, August 12, 1983, the California Heritage Task Force met in San Diego in one of their first regional

meetings/workshops.

The Task Force was created last year by the state legislature to study and recommend policies, programs and legislation to encourage preservation of California's historically, architecturally, culturally and archeologically significant properties. Its sixteen members, including a Senator and Assemblyman, were selected for their prominence in the field of preservation and their familiarity with statewide relevant issues.

At the all-day meeting at the Hotel San Diego, local preservation groups and interested citizens were given full opportunity to contribute to and participate in the Task Force meeting. Pat Schaelchlin, chair of SOHO's Ad Hoc Committee for the study of Problems of Preservation in San Diego, addressed the meeting on SOHO's behalf and described the preservation issues SOHO's Board of Directors had identified after review of the Public Comment Document distributed earlier by the Task Force.

The goals of the Task Force during this one-year life span, are to:

1. Develop recommendations and legislation to encourage and enable preservation through no-cost or low-cost means.

2. Develop a cohesive statewide preservation policy.

3. Recommend actions which will encourage the state, local governments and private citizens to recognize and conserve their historic and cultural resources.

4. Develop positive incentives for preservation rather than primitive regulations, and provide financial, cultural and social rewards.

In response to these goals, San Diego preservationists raised the following issues for Task Force consideration:

- 1. Improved funding and financial incentives, such as reduced property taxes, expanded charitable donation deductions, and the elimination of redlining by lenders in older neighborhoods.
- 2. Expansion of land use mechanisms to encourage preservation, such as the availability of conditional use permits for adaptive reuse of designated structures, state guidelines for local governmental action encouraging preservation related land use planning, and the use of overlay zones to protect historic neighborhoods.
- 3. The interaction of local historic site board functioning with California Environmental Quality Act's environmental review requirements as upheld in San Diego Trust & Savings v. Friends of Gill, and the effects of such interaction on local site designation.

The Heritage Task Force has prepared a seven page "Public Comment Document on Task Force Proposed Issues and Programs" which identifies the issues to be addressed in this 1983 project and requests public comments and suggestions on each issue. Copies are available from Ron Buckley, City Planning Department, 236-5571.

Every San Diegan with an interest in the future of preservation in California should request a copy of this document, review it, fill it out and mail it to the Task Force in Sacramento (it is pre-addressed). This is our one opportunity to actually participate in the legislative and policy making process for preservation and our one chance to secure legislation and governmental action positive to our interests.
