
#### INTRODUCTION

### New President for National Trust

NATIONAL TRUST BOARD OF TRUSTEES SELECTS NEW PRESIDENT;

BALTIMORE, MD., OCTOBER 27, 1984; J. Jackson Walters, a 43 year-old lawyer with a career in land use and real estate development law and public management has been named president of the National Trust for Historic Preservation. The announcement was made by Alan S. Boyd, chairman of the board of Trustees, at the organization's 38th National Preservation Conference in Baltimore.

In making the announcement, Mr. Boyd said, " The National Trust, with the participation of the entire preservation community, has recently set an agenda for the next five years with its strategic planning process. That agenda includes moving toward financial self-sufficiency, reaching out to new audiences with the message of preservation and serving as an advocate for historic buildings before Congress, federal regulatory agencies and, whenever needed, in the courts. Mr. Walter's experience in managing both government agencies and a nonprofit corporation in Washington, D.C., together with his background in land use and planning law and real estate development, makes him particularly well qualified to lead the National Trust in converting that agensda for the future into a reality."

Mr. Walter comes to the National Trust from the National Academy of Public Administration in Washington, D.C., where he was the president. The academy is a federally chartered 350 member "who's who" of practioners

scholars of public management. It advises Congress, State, federal and local officials and the President on the practical aspects of government administration. During his tenure at the National Academy, the organization achieved

it s goals of obtaining a federal charter, made significant progress in building a general endowment and publiished America's Unelected Government: Appointing the President's team, a primer on presidential personnel recruiting for which he was chief editor. Before joining the National Academy, Mr. Walter was director of the U.S. Office of Government Ethics from 1979 to 1982 under Presidents Carter and Reagan. He was the first person to hold the position and put into place a management program to enforce federal conflict of interest laws in the executive branch. During the 1980-1981 presidential transition, he personally had to review the financial and conflict of interest circumstances of all Reagan Administration appointees. Mr. Walter's career in public management began in 1976 when he was appointed the Secretary of the Florida Department of Business Regulations by Governor Rueben Askew. In that position he was responsible for collecting state taxes from regulating certain industries including pari-mutual betting, alcohol beverage and tobacco sales as well as the state's hotels, restaurants and condominiums, land sale companies and various licensed occupations. His legal career included private practice where he specialized in historic preservation, environmental, land use and municipal law. He was also director of planning and governmental relations for Land/Vest, Inc., a major rural land marketing and devdlopment firm in New England. Mr. Walter received his law degree from Yale Law School in 1966 and his A.B., cum laude, from Amherst College in 1962. He and his wife Susan, Manager of State Government Issues Operations for the General Electric Corporation, live in Washington D.C., where their Allison, attends Sidwell Friends School. They also own a farm in the historic village of Waterford, VA.

FOUR-STORY WING PLANNED FOR NEW SAN

The proposed San Diego Art Center has a developer and a plan for building a \$2 million, four-story wing as part of its restoration of the Balboa Theater adjacent to Horton Plaza downtown, it was announced Sept 4, 1984.

The Balboa Building Partnership, a limited partnership consisting of Lincoln Land Investment Corp. and the Art Center, plans to develop the San Diego Art Center, which includes a \$6.5 million adaption of the Balboa Theater and the construction of the new wing. There will be a total of 76,000 square feet of galleries and 18,000 square feet of retail space.

Mayor Roger Hedgecock, Councilman Uvaldo Martinez and the Centre City Development Corp. yesterday endorsed the new plans, which lay to rest recent doubts about the feasibility of a project announced last fall by La Jolla arts patron Danah Fayman.

Chris Mortenson, president of Lincoln Land Corporation, has completed other multi-million dollar restorations downtown, most recenmtly the Golden Lion Tavern,

(where SOHO just had our general meeting) and the Exchange Buil;ding on Fourth Ave across the street fron the proposed new wing of the San Diego Art Center.

"The announcement that Lincoln Land Investment corp, and Mortenson are involved in the project is a significant step toward ensuring that this development will come to fruition" said Gerald Trimble, executive vice president of CCDC, the City Council's redevelopment arm.

Russo Family Enterprises and the

Suburban Theater Corp. are joint owwners of the Balboa Theater and have yet to come to terms with the CCDC, which must acquire the property prior to resale to the Balboa partnership. "We were recently told", Paul Russo, one of the owners, said, that "CCDC would aquire the property in November by condemning it and forcing acquisition by the city for resale to the San Diego Art Center."

Trimble said he hopes that a public hearing on the acquisition of the theater and the land will be held by the City Council on Nov. 15, 1984, with a subsequent sale of the complex to the Balboa Building Partnership in the spring.

Both the conversion and the new wing were designed by Richard Weinstein abd Associates of New York, in conjunction with Pegasus Architecture and Desogn and the Jerde Partnership, both of San Diego.

Architects' renderings of the new wing were unveiled at a press conference arranged by CCDC.

The wing will extend from the Balboa Theater half a block south to the truck ramp and parking garage for Horton Plaza. Retail shops are planned for street level; the upperthree floors will house exhibition space, storage space and an auditorium for the museum.

"Elements of the San Diego Art Center project which are not yet finalized are financing arrangements, the exact level of public subsidy and the extnt of participation by Earnest W. Hahn Inc.," said Trimble. Hahn is the developer of the Horton Plaza retail, restaurant and entertainment complex scheduled for completion next August.

"We've already halks with Hahn and his chief executive officer, John Gilchrist, about the integration of the parking for the Art Center and Horton Plaza and the integration of people coming in. The total integration of the retail space

AD HOC COMMITTEE RECOMMENDATIONS:

Here Today, Here Tomorrow, is the theme of a report by SOHO's Ad Hoc Committee. Led by Pat Schaelchlin, the committee suggests a plan enabling SOHO "to answer the contemporary challenges of preservation in San Diego".

The committee recommends that SOHO take the following steps: voice its concern with the future of Heritage Park, develop a broad committee

format to include general membership as well as the board of directors (advisory, membership, financial, fundraising, nominating, etc.), enhance its image through an active public relations program (conferences, speakers bureau, publications, networking), generate funds for projects (grants, membership drives, fundraisers,

publications), undertake projects which reflect us as an active preservation force in our community ( acquistion of real estate, development of a preservation selfhelp packet, involvement in historic surveys).

The Ad Hoc Committee stresses that through implementation of its suggested plan, SOHO will develop sufficient resources to carry out ambitious projects in the future.


all of it, Not to mention the fact that some modifications will have to be made to the existing and SOHO will structures be watching with an eager eye.

Mr. Walter succeeds Michael L. Ainsile who resigned in July 1984 to accept the position of president and chief executive officer for Sotheby's Holdings, Inc. Mr. Walter is expected to join the National Trust in December 1984. The National Trust for Historic Preservation is the only private, nonprofit membership organization chartered by Congress and dedicated to the protection and continued use of America's architectural, cultural and maritime heritage. With regional offices in Boston, Chicago, Philadelphia, Charleston, San Francisco and Denver and a field office in Fort Worth, Tex., it provides technical advise and assistance to preservation organizations and state and local governments. The organization owns 14 historic house museums throughout the country including some of America's most significant historic structures and properties.

# Heritage Park Update

HERITAGE PARK- WHERE DE WE GO FROM HERE?

To better understand who and what's what, let's start with the cast of characters; they include the County Dept. of Parks and Recreation, they are in charge of the Park itself, the maintenance and upkeep; the County Dept of General Services. they are in charge of the building maintenance; the County Counsel, they are in charge of the legal matters; the County Dept of Real Property, they are in charge of the on the buildings; the Leases County Auditor, they are in charge of the bookkeeping; the County Tax Collector, they are in charge of collection of the taxes on the properties; the Major Lease holders, they hold the leases on the individual buildings; the Sub-Leasees, they lease the offices and the shops; the Office of Supervisor Leon Williams, the park is in his district and don't forget the SAVE OUR HERITAGE ORGANIZATION, we are responsible for the entire existance of the park.

Two years ago the SOHO board of directors established the Heritage Park Task Force. The idea was to come up with the inspirational solution to the problems which have plagued the park for years. After several meetings the office of Leon Williams suggested that a marketing survey be conducted to determine the marketing needs of the park. The county therefore authorized the expenditure of some \$10,000 for the survey to be done by the Sanford Goodkin Group. It was done, not very promptly, but none the less it was finally completed some six months later. The suggestions were analysed and the conclusion was reached that a Master Leasee be recruited to oversee the entire operation of

Heritage Park and to create a dialogue with all the characters involved with the park. So the county proceeded with the "Request for Proposal" process. This took another three or four months and, before you know it, it's been TWO years since the formation of the Heritage Park Task Force, and nearly three years since the problems in the park began to get seroius.

Now with the processes all but finished, the RFP's are in, the county has one, only one, response to the RFP. The proposal comes from two long-time residents of the park. Two people who have suffered through all the problems and are still willing to put monies up front to the tune of \$10,000 to Save Heritage Park. Unfortunately, to this date, NO progress has been To date the county made. has spent over \$10,000 dollars and hundreds of man hours, the private sector has spent at least the same \$10,000 and sacrified thousands of dollars in revenues from their businesses.

At this moment, all that is left is hope Dan Banburg and Ruth Pagett have the stamina to put up with the processes thrust upon them by the county and can become the Master Leasees. There are some stumbling blocks, the lease on the Sherman-Gilbert House has been sold to an Tarzana developer and the lease on the Christian House has also been sold.

Now I have some suprises for the new owners of those leases. As far as the county is concerned, the new owners of those buildings hold leases to buildings to be operated as office and shop space and as a restaurant. Now, if you see the sign in the park announcing the coming of a Bed and Breakfst Inn, please hold



### an old ferry...

A plan to return a 52 year old ferryboat to Coronado as a restaurant, which got a cold reception from the City Council six months ago, is still afloat.

Roger Morgan, the Coronado businessmen thwarted in an attempt to put the ferry in Glorietta Bay, says his bid to have the boat located in the Tidelands Project south of the Coronado-San Diego Bay Bridge toll station was to be considered by the Port District on Sept. 28.

"If the port rejects the bid," Morgan said,"the ferryboat will stay in Vancouver B.C., until we can find a suitable location for it. We think it belongs down here where it was part of history for 83 years."

The ferry, the San Diego, serviced the city and Coronado before the bridge opened in 1969. It has been in a Vancouver boat yard since the ferry system was put out of business.

The Coronado City Council in April repealed an ordinance that would have authorized the placement of the ferryboat on Glorietta Bay. Morgan then turned his efforts to the Port District, trying to keep the project alive.

The district has jurisdiction over the Tidelands Project that will include a 200 to 400 seat restaurant, shops and a public park at a site on First Street in Coronado, where the ferryboats once docked.

Morgan said the ferryboat recently was spruced up and is ready to take its place at the dock.

### Cliff Mansion Tours?

NEIGHBORS HAVE A LIMIT TO ADMIRATION

Neighbors of the stately Cliff Mansion on Sunset Cliffs Blvd. are the first to admit that the 58-year old structure is a fascinating place, quite worthy of admiration. The last thing they want, however, is a museum in their backyard.

Thus, when the mansion's owner, Dr. Joseph Ryan, recently applied for a permit to open his ornate doors to regular tours and musicial events, the neighbors came out in force against it.

"This is a quiet, residential area; it's not the right place for that kind of thing," said Betty Cowan, wholives next door and has collected the signatures of 39 neighbors opposed to the idea. "Sure, it's a pretty house. but with the beaches, we have enough people here' you don't have to bus people in."

Ryan could not be reached for comment, but city planners said his main intent is to offer groups a glimpse of his 19 room residence and its wonderous marble stairway, impressive stained glass windows and lavish furnishings. The two story structure, built by Sunset Cliff developer John P. Mills in 1925-1926, is a designated historical site.

The permit application went before the Planning Commission last week, and commissioners agreed to visit the mansion on Nov 8, 1984, before making a decision. a second hearing is scheduled for Nov. 15,1984.

Meanwhile Ron Buckley, secretary to the city's Historical Site Board said,"It seems like a perfectly good idea to me. It's a magnificent mansion and its builder is significant in San Diego history."

Buckley said that Ryan, who works for the alcoholism program at Sharp-Cabrillo Hospital, plans to donate tour proceeds to an alcoholic rehabilitation foundation.

Cowan and other neighbors say, though, they are worried the tours will lead to parking problems, security risks, and litter from possible snack and souvenir stands at the mansion.

"Why would anyone have a museum in an R-1 zone area?" neighbor Ken Zumwalt asked.

Buckley said there is only one other, similar historic home-museum in the city, the Villa Montezuma in southeast San Diego, an arrangement that is a good one sharing history with residents and tourists.

"It takes a lot for someone to open up their home like that." he said. "Apparently, people are always coming by, and he (Ryan) invites them in."

Long time neighbors of the Cliff Mansion are not quite as enthusiastic about all the attention.

"I've lived here 25 years, and this has always been a problem," said Zumwalt.

At various times the house has been a boarding house, a location for weddings, bar mitzvahs and movies, and even the setting for a beer commerical.

"That (the beer commerical) was just great," said Cowan, sarcastically. "They were giving out free beer to everyone".

One neighbor complained that portapotties were once placed under his bedroom window during a designers showcase tour.

Further, neighbors claim that the Cliff Mansion and its builder, Mills, are not all that historically significant. Mills, a somewhat controversial figure, was penniless when he left San Diego in 1930- his magnificent mansion was sold at auction.
