





CEDAR STREET HOUSE FINDS A HOME

We are happy to report that the Cedar Street house has been saved. A young man from the north county plans to move it to Leucadia and restore it as a residence. Although SOHO is not in the business of moving buildings to save them, we believed this was a last resort to save this small, turn-of-the-century, neo-grec house. In its place the architect, Rob Quigley, will build his new offices. He donated the house to SOHO in the hopes we could find an owner.

SOHO learned of another house which will be destroyed if not moved. The house is currently attorney Mr. Paul Kennerson's offices at 1665 Union St., San Diego. The building is a victorian and recently restored. Mr. Kennerson's efforts were awarded a SOHO People in Preservation Award in 1984. GENERAL MEETING REVIEW

SOHO's thrice annual meeting was held Saturday, March 29, at Forum Hall. Judy Schaffer of Advanced Video showed SOHO's new video, "An Introduction to SOHO". The video depicts SOHO's history, the moving of victorian homes to Heritage Park, excerpts from speeches made at the Victorian Summer's Eve and Horton Plaza rededication. The video beautifully portrays our hopes and vision. We will view the video at noon in Senlis cottage for San Diego by Design Week, June 23-27.

The order of business proceeded with each board member presenting committee reports. President Sue Skala related SOHO's goals and achievements in neighborhood "watch dogging" and preservation and the board's goal to work smoothly with committees drawn from our membership. Joe Jones explained that the Education Committee participated in the San Diego Tijuana International Fair, presenting awards to two students. Anna, Development Director, updated us on the progress of the Primer, which will be printed in May. A second editor and a graphic artist volunteered their services to help expedite the Primer's publication.

Kathleen Kelley-Markham, SOHO's new Government Affairs Director (unanimously voted to the board at this meeting), presented many projects that SOHO is monitoring: the formation of the County Historic Sites Board, the Balboa Naval Hospital, the City of San Diego's site ordinance, the Plunge and Rollercoaster proceedings and the creation of an historic district on Seventh Avenue (Gill residences). Kristin Aliotti related the current activities centered around the Balboa Theater. Paul Amidei announced the workshop schedule to begin April 12. David Goldberg pitched the up-coming San Francisco Tour over the Memorial Day weekend. Kathryn Lyon presented SOHO's annual budget.

SOHO's Volunteer of the Year Award was presented to Elsie Spangler, having been nominated by Nettie Scarry, the former year's recipient.

The meeting ended with an open forum for members to voice their opinions about the organization. Most liked the idea of "Reflections" published once a month in a smaller format if need be. News from other historical societies should be included. All agreed that a Volunteer Chairman and committee should be established to filter new members into committees (right now we rely on the member to initiate an interest). The Partners in Preservation project was applauded and most liked the idea of searching in a low income area.

FROM THE PRESIDENT

Much of the Preservation Action Committee's time and energy is spent on the Balboa Theater issue. The plot twists and is confused with bias statements. I believe you ought to know the facts.

Fact-- The Balboa Theater is a viable and valuable structure. It is one of six downtown theaters. It has 2300 seats, a stage, back stage facilities with running water, and a large fly loft. Its interior is unique, in that it captures a Moorish feeling with tile ceiling, light fixtures and working replicas of waterfalls on each side of the stage.

Fact-- The same architects who designed the Balboa Theater designed the Fox Theater. The construction of the theaters was within four years of each other. The same materials and method of construction are similar. The Fox Theater was readily restored, demonstrating an ease of structural retrofitting and maintenance of integrity.

Fact-- The issue focuses on saving the interior and maintaining its use as a theater. The Art Center desires to change the use, adding three floors to the interior. Their intent is to structurally connect the new floors to the exterior skin, thus creating a building within a building. We contest that any change to the interior is damaging and irreversible.

Fact-- To replicate the Balboa Theater would be more expensive than to restore it. The new Lyceum, which will have one-third the capacity of the Balboa and will not have a fly loft, demonstrates this fact. In a recent San Diego Daily Transcript article the Lyceum dilemna was stated. The cost per seat is \$10,800, a cost of \$7.5 million to the city (an over-run of approximately \$5 million).

Fact -- The Art Center has defaulted on every commitment and has not yet come forward with a concrete concept or financial statement.

Fact-- Public inquiry would reveal a strong bias toward the Art Center. The Center City Development Corporation, which handles downtown redevelopment for the City Council is pro Art Center and has allowed the Art Center to default without reason and is willing to rewrite the contract to suit the Art Center. At least half of the CCDC board has not seen the interior of the Balboa.

Fact-- Many structural studies on the Balboa Theater have been conducted. Each points to the fact that the structural connections for the seating balcony do not meet present day seismic code regulations. Since the remainder of the building meets requirements for historic structures and because the building could maintain the same use, minor structural retrofitting is only needed.

The work shops will be held beginning at 10:30 AM on the dates listed below beginning April 12 as follows:

April 12, Orientation: 3333 Front Street, San Diego. This will include a slide show to introduce to "The Craftsman House", and other information and hand-outs. It will be held in an 80-year-old Victorian brownstone.


April 19, How to begin, 7329 Eads, La Jolla. The basic steps to the restoration of a Craftsman House. Some practical solutions to the many problems associated with restoring an "old" house. This session will be held in a classic California bungalow.

April 26, Interiors, 959 C Ave., Coronado. Selections of colors, materials and finishing techniques for walls, floors and fixtures. Both for interiors and exteriors. Conducted by local restorer Jim Gibson, this session will be held in the historic Hinde House (c. 1893).

May 4, Landscapes, 1525 Fort Stockton Drive. How to create the craftsman period garden. A practical approach to the cottage garden. Local Landscape Architect Gail Garbine will conduct this session at the Mission Hills Nursery.

May 10, Craftsman Furniture, 431 J Street, San Diego. Samples of period furniture, selection of interior colors, materials and furnishings for the craftsman period. Scott Kendrick, a specialist in Stictly furniture, will conduct this session at his shop, where the group will be exposed to a wide variety of mission style furnishings.

HISTORIC BUILDING CODE FORUM

SOHO sponsored a forum on April 2 to discuss the use of the State Historic Building Code in San Diego. Attending were architects and planners who are involved with preservation projects. Currently three codes apply to restoration and construction of historic structures; the Uniform Building Code with San Diego amendments, the State Historic Building Code, and a not yet released modification to Division 88 of the Los Angeles Ordinance, seismic retrofitting for masonry buildings prior to 1936. Each code is somewhat ambiguous and arbitrary in interpretation, therefore, historic building projects become entangled in a maze of arbitration and appeals before approval of plans and issuing of a building permit is accomplished.

All present resolved to review the State Historic Building Code and relate questions about interpretation to John Henderson, who is currently on the State Historic Building Committee. Some present are members of the Seismic Retrofitting of Masonry Buildings Committee. They will present concerns discussed at the forum to that committee.

The forum was successful. We hope that some of the bureaucratic red tape will be alleviated and that arbitrary code restraints will not discourage the preservation of San Diego historic structures.
