

INSTREAM PRESERVATION

We thought that our membership might be interested in a recent poll conducted by the Gallup Organization and the Urban Land Institute. The following is an excerpt from the "Editor's Column" from **Preservation News**, July 1986, the monthly newspaper of the National Trust for Historic Preservation.

rn fact, the numbers were overwhelming: 97 percent said they should have a strong voice in preservation questions; 90 percent of city dwellers said they would

give time and money to improve their environs; 69 percent favor tax deductions for restoring historic houses; 55 percent approve of tax credits for commercial rehab; 70 percent say a good job is being done of restoring historic buildings; and more than half say history experts should be called up to help decide the fate of buildings.

SOHO members, we are not alone! This poll proves that the majority of the public is aware, and worried about the fate of the built environment. As we have always known, SOHO is a grassroots organization representing the legitimate concerns of all types of individuals and groups. Preservation is good planning, good design and good citizenship.


PRESIDENT'S LETTER

"We are making a dull porridge of parking lots and cheap commercialism to replace the forms and evidence of American ivilization. The buildings espised and sacrificed today are, or would have been tomorrow's heritage."

As we begin a new year I would hope that we not only reflect on where we have been but also where we are going. SOHO realizes that not every old building should be saved, however, the design of new buildings should respect and compliment the existing historic fabric of our environment.

New buildings should add texture, pattern and rhythm and scale, but many times these qualities are actually destroyed rather than enhanced. We have reason to be concerned. Tomorrow's heritage vanishes daily. Cheap, bland motels to serve downtown and the convention center, have invaded and lighted most of Little Italy. Residents of North Park, Sherman Heights and Uptown watch the bulldozers arrive weekly (sometimes without demolition permits). The Naval Hospital Complex, although documented to be historically and architecturally significant, is being treated as expendable. The Navy's offer to demolish (free) any or all of the buildings has led some City officials to ignore the cultural potential for these structures.

Our older commercial corridors, defined by coffee shops, movie theaters, supermarkets and car dealerships represent an urban landscape created by the automobile. Many buildings along the boulevards are viewed by many as outdated or trivial, but they too may be landmarks.

Our Egyptian Revival structures, our R.M. Schindler Pueblo Ribera courts, the Sweet House and our Spanish Colonial Revival Plunge building are also part of tomorrow's heritage. As we look towards the coming year, let us expect the best—and that means anticipating and planning for tomorrow.

BUILDERS WATCHERS SERIES

America's Architectural Roots:
Ethnic Groups That Built America
Dell Upton, Editor

Published on the anniversary of the Statue of Liberty's dedication, America's Architectural Roots is the first book to look at the rich array of ethnic architecture in America. A wholly new way of viewing American buildings, this pocket-sized book features 22 groups and traces settlement patterns, building types and technologies and decoration, paying special attention to problems such as adapting Old World building techniques to America's terrain and climate.

In a country built by immigrants, much architecture has been viewed as simply "American." Yet, the variety of houses, farms, villages and even cities that distinguish portions of the country reflect not only differences in climate, topography and resources but also the ethnic diversity of their builders.

The book, a Preservation Press publication, explores the forces that influenced immigrants' designs. Few duplicated the architecture of their homeland but, instead, adapted their designs to the new country. Geographic changes, variations in living patterns and the availability of building materials were all taken into consideration.

Each essay is illustrated with photographs and plans showing the house types, community buildings, particular details and floor plans. Also included in America's Architectural Roots is a list of furthur reading and additional information sources and an index.




ART DECO/MODERNE SOCIETY MEETING

BALBOA PARK NAVAL HOSPITAL BUILDINGS


After several continuances, the City Council will finally decide e fate of the Naval Hospital adildings. The crux of the issue is whether or not to retain most, some or none of these historic structures.

SOHO concurs with the Historical Site Board in advocating the retention, preservation and reuse of most of the original hospital complex buildings. Reknowned architectural historian, Sally B. Woodbridge concluded after extensive research, that this complex of buildings is eligible for the National Register of Historic Places on the basis of its architecture and historical development of the Navy and its association with the City. In addition, Ron Buckley, secretary to the Historic Site Board, has learned that the National Park Service is determining if the complex has potential for designation as a National Historic ndmark. Congress has requested a thematic study of potential National Historic Landmarks associated with World War II in the

The architectural significance of the complex largely rests on the layout, symmetry and relationship of the buildings to one another and to the central courtyards. Retention of only parts of the complex or single buildings will destroy the architectural composition, and diminish the significance of the site. A complete razing of the site will also destroy the historic plant species in the area. Robbed of its attributes, the complex will fail to qualify for National Register/National Landmark Status and related rehabilitation funds.

COHO urges the City Council to cognize and retain this historic complex and consider its use as a natural extension of existing cultural uses in the park.


