### SOHO looks back at its work with the San Diego Rowing Club 1974-1980

The San Diego Rowing Club celebrated it's centennial last year -- but this water-front historic treasure was nearly lost to our city in the early In the Port Comseventies. mission's redevelopment of the harbor, they balked at renewing the Rowing Club's lease on the site. Membership -- divided about continuing in that location or relocating on Mission Bay-lacked resources for restoration and faced the uncertainty caused by the battle for their lease with the Port Commission.

Thanks to the monumental efforts of a small group of concerned citizens, this preservation effort was successful. Pat Schaelchlin, former SOHO President was at the forefront of the campaign to preserve the Rowing Club on that site. She did the research for site designation and the property was so designated by the City Historic Site Board.

## Preservation Politics

Your help is needed immediately to ensure that San Diego preservation moves forward, not back

It's not surprising to note that preservation issues are not being sufficiently addressed through current means. Recently, the City Planning Department began reviewing and revising the General Plan for San Diego (the document that defines City goals and operations).

In their reappraisal, not surprisingly, they found a deficiency within the Cultural Resources Management element of the City's general plan (the Progress Guide and General Plan).

This revelation creates an opportunity and risk. THE

RISK being that preservation efforts could be made more difficult with historic designation given only to those owners wholly in favor of such a designation.

THE OPPORTUNITY -- to create a stronger historic management element within the city's plan (again, the Progress Guide and General Plan) -- for the first time in 20 years!

A new ordinance has been proposed by the City's Historical Sites Board. It would expand the role of the Sites Board -- providing greater protection for historical re-


Even this major step was fraught with frustration, as the Port Commission in a jurisdictional dispute with the Site Board then refused any lease until the designation was removed.

In March 1980, San Diegans for the Rowing Clubhouse, Inc. was formed with members of the Rowing Club, SOHO, and concerned citizens. Pat and Carol Lindemulder appeared before the State Coastal Commission in Newport Beach to assure that the Rowing Club was considered in their Coastal Plan. Appeals were made to The Unified Port Commission to obtain the necessary voter

support. In June 1980, the Chart House, Inc. joined these efforts, bringing the financial support badly needed. Thus the restoration was accomplished.

Celebrating 100 Years -The
Harfield
Timberlake

As SOHO celebrates it's 20th year, the Harfield Timberlake Christian House, home of Lori Chandler's Heritage Park Bed & Breakfast Inn, celebrates it's Centennial! Originally built by Harfield for his wife Myrtle in 1889, this beautiful Queen Anne Style Victorian was located at 1940 Third Avenue just north of Horton's "New Town" where its variety of chimneys, shingles, corner tower and encircling veranda establishes the charm of the "Golden Era" in Southern California.

Harfield Christian was the son of southern gentry who came to San Diego after the Civil War and founded what later became TICOR Company. He was one of the

signers of the original city charter.

The home was lovingly restored through the monumental efforts of Lori and her entire family -- mother, sisters and their husbands -- as closely to the original plan as possible.

It is now furnished with an incredible collection of fine Victorian furniture and memorabilia -- enjoyed by San Diego's visitors and residents alike as a living remnant of our history.

It did not reach its current proud state easily.

The meticulous restoration was a monumental job in itself, but equally challenging was the many bureaucratic hurdles which were overcome in a two year struggle in order to arive at the stage where restoration could finally begin.

Lori Chandler is a fine example of how one person can make a difference -- by having a vision, being persistent and working tirelessly to make that vision a reality. She is an inspiration to all of us who cherish the treasures of our past and wish to preserve the best of it to enrich our present lives.

Our thanks to Lori and her family for restoring the Har-

field Timberlake Christian House to such perfect condition for the arrival of this centennial year. It's a wonderful tribute to our city's past.

#### Egyptian District

On February 22, 1989, the Historical Sites Board of the city of San Diego voted 10 to one to designate an " Egyptian Revival Thematic Historical District". This district consists of five examples of the exotic Art Deco architecture still remaining in the City of San Diego. We thank all SOHO memwho demonstrated support for designation. However, five buildings in this district are still at risk. The owners of these properties opposed the Site Board action and have indicated their intent to appeal the decision to the San Diego City Council. The council has the power to overturn the designation and dissolve the protection of the district.

- 2) a list of Cultural Resources and the historic Site Boards of SD County
- 3) samples of historic resources inventory
- 4) examples of Historic District designation process
- 5) outlines for the procedure (provided by the Office of Historic Preserv-

tion Department of Parks and Rec.)

#### PRESERVING YESTERDAY...FOR TOMORROW

The 14th Annual California Preservation Conference - April 20 - 23, 1989 at the historic Biltmore Hotel in Los Angeles

Topics to include workshops on:

## Heritage Promotion, Interpretation, and Education

Topics include using tourism to promote historic resources, an historic sites roundtable discussion on public relations and constituency development, and sessions on historical interpretation and urban archaeology.

#### Neighborhoods and Small Towns

Sessions include getting started with neighborhood organizing; cultural resources surveys; using planning and zoning; historic districts (local and National Register); providing affordable housing in old and historic buildings; and infill housing in historic districts.

#### **Development and Design**

Sessions include a building codes roundtable, tours to historic theaters and to tax certification projects, landscape restoration and historic landscape design, and additions to historic buildings. Downtown revitalization topics in this track include the National Trust's Main Street program; revitalizing small city downtowns; redevelopment and the Hollywood Boulevard Historic District; and urban main streets in big cities, with case studies of Los Angeles' Broadway and Spring Streets.

#### **Preservation Law and Policy**

Topics in this track include updates on

federal and state law, with emphasis on the California Environmental Quality Act; economic incentives; drafting and using local ordinances. A session on effective political action includes the views of political decision-makers and a crisis management workshop.

#### **State Office Workshops**

While this year's conference is in Los Angeles, subject matter should appeal to Californians from small towns and rural areas as well as large cities. The State Office of Historic Preservation, a conference co-sponsor, is a major participant in the sessions, presenting updates on the new National Register regulations, cultural resource surveys, certified local governments, and the tax certification program. Staff from the State Office will be available to conference participants in specialized workshops, providing technical assistance in particular areas to more advances preservationists and professional consultants.

#### **Building Los Angeles**

Sessions in this track deal with architectural history, a first for the conference. Workshops will focus on Los Angeles' architectural innovations: the work of Richard Neutra, Frank Lloyd Wright, and Rudolph Schindler; the Fifties and "Case Study Houses," and the Watts Towers.
