## **People In Preservation Awards**

Seventeen well-deserved awards were distributed at SOHO's People in Preservation Awards dinner held May 17 in the colorful Hotel Bar Restaurant.

Over 100 guests loudly applauded the wide range of recipients as they came forward to receive their awards against a backdrop of color slides depicting the winning entries. Both individual achievement and group efforts were recognized.

#### **Awards Jury**

Earlier, a panel of judges had carefully screened and considered a host of nominated entries before deciding on the eventual winners.

The awards jury was made up of Chairperson and SOHO board member Angeles Leira; Jeffrey Shorn, A.I.A., member of the San Diego City Historical Site Board and dean of the New School of Architecture; Mary Ward, County Historian and 1989 Preservationist of the Year awardee; Lynn Benn, member of the City of San Diego Planning Commission; Carol Landsman, past Chair of the Community Planners Committee; and David Swarens, SOHO President.

The evening began on a festive note with a cocktail hour followed by a sitdown dinner and the awards ceremony. The awards were announced and distributed by the members of the awards jury.

After the awards ceremony a fundraising auction was held with Ron Oliver, Executive Vice President of Central City Association, serving as a most capable auctioneer.

### From the President...

On the matter of the late Aztec Brewery buildings, at the City Council meeting of March 12, the Council directed the City Manager to evaluate any negotiations regarding acquisition of the buildings. Up until about May 18, SOHO understood that Foote Development Company had agreed to enter into a 90-day purchase/option of the property. It now appears that the city failed to assist in the negotiations between Foote and Northern Automotive.


The Foote proposal would have provided for housing opportunities, commercial services, easy access to bus and trolley lines, a community center and preservation of the brewery buildings.

Foote proposal... a quality neighborhood revitalization project...

This would have translated into affordable housing, jobs, a larger tax base for the city and a quality neighborhood revitalization project.

The Foote proposal was supported by SOHO. The proposal could have been negotiated in good faith by all parties and could have resulted in an innovative Enterprise Zone project.

#### Preservation News Bits...

### Julia Liffreing House

A fter years of meetings, hearings, disputes, proposals and counter-proposals, and much involvement by SOHO it appears that a final and agreeable solution has been reached for the East County landmark known as the Liffreing House.

Standard Pacific, the latest owner of the property on which the house sits, proposes to move the house to another location on the property and donate the title for it plus 1.8 acres of land to the El Cajon Historical Society. In addition, the society would receive \$250,000 towards restoration and landscaping purposes.

At the request of the society, the County's Historic Site Board is the latest entity to voice approval of the proposal. Earlier, following a presentation by the Society, SOHO's board of directors voted to support the proposal.

An Environmental Impact Report (EIR) is now in preparation.

### **Balboa Theatre Festival Days**

SOHO thanks the tour guides who volunteered their time over two weekends to help this project. The enthusiasm of the guides towards the historic downtown landmark was shared by all those who toured the theatre.
