

CONCERN FOR THE CALIFORNIA

For several months the SOHO board has been concerned with the future of the downtown California Theatre. After lengthy discussions with the San Diego Community Foundation and Albert C. Martin Architects (representing Hillman Properties) on a variety of issues relating to the building elements and use of the theatre, the board has taken two actions.

It supports designation by the city's Historical Site Board and recommends incorporation of the facades into the new high-rise proposal.

SOHO believes that it is important and feasible to save the exterior architectural elements of this building.

If anyone has an interest to be heard on this matter, it is scheduled for discussion by the site board on Aug. 22.

Reflections From the president...

The following is a reprint of an article which appeared in the July issue of <u>Historic Preservation News</u>, the nationally distributed newspaper of The National Trust For Historic Preservation.

"We erred on the side of good faith," reflects David Swarens, president of Save Our Heritage Organisation (SOHO) in San Diego, after the owner of the Aztec Brewery building last month demolished the structure. SOHO had opted against legal action that would have precluded demolition after the owner entered into talks with "a developer with extensive background in both residential development and historic preservation," says Swarens. Built in 1911 as the Savage Tire Factory, the structure became the brewery of Aztec Beer after the repeal of Prohibition. Since the late 1950s it had reverted to something akin to its original use as a warehouse for a tire company. The building had received two local landmark designations, one for the entire building, the other for the decorative elements of a tasting room that was part of the 1933 conversion. In exchange for the public donation of the tasting room accouterments, the city had lifted the landmark designations. The tire factory/brewery, a brick building distinguished by parapets and copious steelsashed fenestration, is to be replaced with a warehouse.


WORKSHOPS ARE BACK!

SOHO will resume its popular "Home Restoration Workshop" series on September 15th. Designed to address the basic issues of restoration and maintenance of older homes, the series will consist of three workshops. The first workshop will be held in a Mission Hills residence where architectural styles, historical research procedures, historic designation, and supportive government agencies will be discussed.

On Saturday, September 22, the discussion will center on planning your restoration project and working with professionals. Our hosts, recent winners of a SOHO "People in Preservation" Award, will comment on their experiences in restoring their Victorian home, located in Sherman Heights. Finally, on September 29, attendees will go to La Mesa, where period interiors and landscapes will

be discussed in the environs of a Craftsman home and garden.
