Restoration of Gill-designed Church Advances

he restoration of one of Irving Gill's most significant design works is about to become a reality. The First Church of Christ, Scientist, San Diego, has selected a contractor, Tony Wanket Construction of Vista, and the first signs of construction are expected to begin within 30 days. This marks the beginning of un-masking the beautiful Gill design that was covered over in a 1953 "modernization" remodel.

Fortunately, the 1953 remodel did nothing to disturb the fabric of the original building except for the height reduction and redesign of the bell tower. The exterior dome had at the time of the remodel, been removed several years earlier because of leakage and being blacked out during the war years. These two prominent architectural features will be reconstructed to their full dimensions. Approval for their design was accomplished by a variance request which was heavily supported by the historic communi-

ty as essential to an authentic restoration and to add proper proportions to the building design.

The original window and door openings have been encased in brick and stucco all these years and will once again bring natural light to the auditorium through the redesign of the architectural firm, Bokal, Kelley-Markham. The San Diego Historic Site Board has designated the building a historic landmark. In announcing its decision, the Board characterized the restoration as "a wonderful gift to the City of San Diego."

The Site Board based its designation on the building's age and prominence in San Diego history, its famous designer, Irving Gill, and also on its significance in the designer's career. The 1909 design was the second of three commissions for the Christian Science community. The first design in 1904 is at the corner of 3rd and

President's Column

December 6, 1993, Senlis Cottage

am sitting here, in SOHO's home, hoping to get at the heart of matters. This small building, formerly a modest residence, has seen many changes. Not the least of these, of course, was its own relocation to Heritage Park. But it is within the unchanging identity of this structure that I find my clue.

The rooms wherein I sit retain their original proportions. I imagine that in listening closely to the silence they might return to me the laughter of holidays past. Other parts of the cottage are so extensively altered as perhaps to have lost their echoes. Yet the thing as a whole retains its integrity, establishes a continuing presence.

Such continuity of identity in the present is our anchor in the flux of history. Our understanding of our world, our very selves, is predicated upon this evidence of those times which have gone before us. Objects, buildings, places each provide an individual perspective on all the changes that have occurred since they came into being. These instantaneous points of view give us a sense of scale as we gaze back down the corridor of years.

In a species notorious for its hunger for the future, whence arises the impulse to save the past? Does it come from a merely pragmatic desire to avoid mistakes, self-preservation in the narrowest sense? Or is there a wider reason?

Let's look at time. Not the time of the physicist or the philosopher, for the moment, but the time of the human family, history, the stuff of the calendar. Today, in the Christian calendar. is the feast of Nicholas of Bari. Throughout Orthodox Christendom and the Slavic world, this is the annual day of gifts. Soon we begin Hanukkah, the Jewish Festival of Lights. A while more and American Christians will exchange gifts, some on Christmas Eve, others on Christmas Day. Those of Hispanic heritage may actually retain the spirit



throughout the Twelve Days to the Epiphany.

In each of these, I am sketching quickly, only from my own experience, what I know of the ensuing "moon." The key observation is that each ethnic group follows a different tradition, is, in fact, defined by that tradition. Group activity is group identity. The sense of tradition is certainly the property of no one group. Nor is it the exclusive possession of those individuals given to the indulgence of nostalgia.

Tradition is living heritage. It is the annual pattern of each group's historical identity. At the Jewish feast called the Seder, a very important question is asked: "What is different about this day?" Thus begins the ceremonial retelling of one of the defining episodes of Jewish history. And for every people, that particular difference of one part of time gives structure and meaning to their identity. Traditions are repeated to maintain that identity, just as an individual will return to a particular place, a favorite building, to re-new their sense of self.

That same need to orient a group's place in the universe by the use of traditions is satisfied by the preservation of cultural resources or architectural treasures, the Declaration of Independence or Independence Hall. In the ever-changing landscape between the quantum of the physicist and the eternity of the philosopher, the Senlis Cottages are the touchstones of our common identity.



SOHO Awarded Navy Contract

The U.S. Navy has awarded SOHO a \$20,000 contract to establish an archaeological data management system for the artifacts/ecofacts from the Ballast Point archaeological project on the U.S. Naval Submarine Base in Point Loma. The contract is for one year, and is consistent with the Archaeological Resources Protection Act of 1979, which requires that archaeological resources be surveyed, analyzed, curated, and stored properly. Ron May will serve as SOHO project manager.

The work plan involves several detailed and technical phases. Responsibilities include: setting up the general analytic catalog to arrange artifacts by function and type; setting up a museum conservation collections management system; searching for curated items; developing a team to oversee the installation of hardware/software and data entry processes; developing a team that will operate the data management system; photographing and video recording artifacts; and developing a policy manual with forms for object tracking.

SOHO's action, in my opinion, was long overdue. I hope SOHO can show the City of San Diego that preservation of here historic resources will help lead her from these economic doldrums.



The California State Library Foundation writes... that one of the principal missions of the California State Library has been to preserve and protect the state's cultural heritage through the acquisition of book, maps, prints, manuscripts, and ephemera that illuminate every aspect of the state's development. In the Spring, the Library will expand its Sacramento facilities when construction is completed on the Library and Courts Building II.

However, an immediate dilemma is that the state will finance only permanent construction costs in the new building, not furniture and equipment in public service areas such as tables, chairs, and microfim readers and workstations.

State Commission Votes to Designate Aztec Bowl

At a meeting on 18 February, the State of California Historical Resources Commission sided with preservationists when it voted 6-1 to recommend Aztec Bowl for the National Register of Historical Places. The commission reached its decision after listening to a number of speakers from both sides argue over the significance of the cobblestone and concrete structure located on the campus of San Diego State University. The university adamantly opposes designation and wants to tear down the WPA project that was completed in 1936 and build an arena in its place.

Interestingly, commissioner Patricia Cologne, who lives in San Diego, cast the lone vote against designation.

Ann Rizzo, the SDSU student who has led a 2-year fight to save the bowl, and others insist the structure, because of its WPA-background, its age, the importance of the 1963 visit by President John Kennedy, and other memories, is worthy of preservation. Among those who spoke or were present to support "designation were SOHO president Robert Broms and SOHO members Paul Johnson, Vonn Marie May, Kathleen Kelley-Markham, M. Wayne Donaldson, and David Swarens. In his remarks, Swarens focused on the bowl being one of the largest WPA (Works Progress Administration) projects in the San Diego area. He described the bowl as a "key component of the original campus core plan, achieving an efficiency if site use based on a sensitive elaboration of natural design by using vernacular and site-related materials."

While the action by the commission is good news to preservationists for now there is still a fight ahead because the university reportedly plans to oppose the recommendation when it is considered at the national level.

SOHO v. City of San Diego, Et Al

As this edition of "Reflections" went to press, SOHO's suit against the City of San Diego and its Redevelopment Agency, concerning the fate of the historical structures at the Southwest corner of Fifth Avenue and K Street, was set for trial Thursday, February 24, at 9:00 a.m., in Department 17 of the Superior Court before Judge Judith L. Haller. The T.M. Cobb Co. and sign shop complex are listed as contributing structures to the Gaslamp Quarter National Historic District on the National Register of Historic Places.

The remaining buildings, architect W.S. Hebbard's 1894 Clemens warehouse, another 1985 warehouse attributed to Hebbard, and the 1896 First and Last Chance Saloon, were recently cited in the National Trust for Historical Preservation's list of threatened structures.
