# **SOHO** Receives Governors Award

# Congratulations SOHO members

The governor's office in Sacramento recently announced that SOHO had been selected as one of fourteen groups statewide to receive the prestigious 1995 Governor's Historic Preservation Award. Governor Pete Wilson commended the groups for "their special efforts to help protect our state's heritage and for projects that have demonstrated an outstanding commitment to excellence in historic preservation." The awards were scheduled for be presented May 1, on the steps of the State Capitol. SOHO president Vonn Marie May

planned to represent SOHO at the ceremony. (More on this in the next newsletter.)

SOHO is being recognized for its efforts in taking the lead in the repair and restoration of the historic St. Francis Chapel in Warner Springs Ranch. The project consisted of repairing the roof adjacent to the bell tower, making new adobe blocks, excavating the entire interior bell tower, and concreting from ground level to the top of the structure.

The Governor's Historic Preservation Awards are presented annually

under the sponsorship of the State Office of Historic Preservation to organizations whose contribution demonstrate outstanding commitment to excellence. The purpose of the awards program is to increase public awareness of historic preservation; promote excellence in historic preservation; recognize organizations that have made significant contributions to the advancement of historic preservation and have demonstrated exceptional commitment and achievement in the stewardship of historic properties; and recognize projects of excellent quality.

## Appeal Heard on Cobb Lawsuit

On April 19, a panel of three justices heard the arguments on SOHO's appeal of its lawsuit against the City of San Diego over the city's handling of the Gaslamp Quarter property known as the T.M. Cobb building.

Presenting arguments on behalf of SOHO were, SOHO's attorney William Adams and attorneys from the National Trust for Historic Preservation, the California Preservation Foundation and the State Attorney Generals Office.

A decision on this important preservation project is expected sometime within the next 60 to 90 days.

### President's Message Vonn Marie May

As we begin our observance of the 50th anniversary of the end of World War II, we now have the opportunity to put San Diego's military contributions in full context and appreciation.

Consider this: 1942 -- the West Coast -- months, if not weeks, after Pearl Harbor the U.S. is fully mobilized and inspired to right the wrong of that infamous day. Funding from Washington flowed like a 100 year flood event into the City and we were at optimum output and challenge; Balboa Park converted to a medical facility and was renamed Camp Kidd for the fallen Admiral. Naval Training center trained newcomers at its most accelerated rate. Military housing mushroomed throughout the City. San Diego more than responded to the call, we transformed ourselves into a wartime city of the first order.

From personal family stories I have always imagined the war effort to be one of great vitality and unity. A unique time that can only happen under extreme circumstances. My parents were both in the military, my mother was a Captain in the Navy Nurse Corps stationed at Balboa Park, and my father was a Marine in the Carlson's Raiders wounded in the Pacific and recovered at Balboa. (My aunt was also in the Marine Corps and my uncle was in the Air Force)

So now a half century later with the dust settled a new age military has emerged and we face restructuring from quite a different mission. World War II is now are recent history yet we are still generationally connected and feel the relevance from lessons learned that affect today's decisions. This city rallied in full measure and we should be awed and proud. We should also preserve this history for the succeeding generations to "walk-through" with the same amazement thereby maintaining that connection.

SOHO, the National Trust for Historic Preservation and the Department of defense through the Legacy program present Preservation Week 1995 for your enjoyment and reflection.

## Memorandom of Agreement Concludes Chollas Heights Debate

After a year of meetings and often intense negotiations involving the U.S. Navy, the Federal Preservation Advisory Council, the state Office of Historic Preservation, the Eastern Area Planning Committee (a community advisory group) and SOHO, the parties signed a Memorandum of Agreement (MOA) that defined the future of the Navy-owned Chollas Heights Radio Transmitting Facility. The terms of the MOA call for dismantling of the landmark three radio towers, long a familiar sight in the area.

The MOA also provides for the interpretation of the site's unique history as a link in the first system from which meaningful radio signals could be available worldwide. Still, the loss of the 600-foot tall towers will seriously impact the significance of the historic district and the SOHO board of directors spent a lot of time discussing the matter before deciding to affix its signature to the MOA.

Developed around the time of the first World War, the Chollas Heights facility, which has only recently become assessible to non-security personnel, consists of, in addition to the towers located behind the Grove Shopping Center, acentral transmitter building in the Mission Revival mode, utilitarian buildings associated with maintenance and technology, and bungalow style residential buildings including a barracks.

Under the terms of the MOA, Building "1", the transmitter building, will be restored, and will include a museum, interpreting the site, its history and technology. The museum will be open to the general public.

All utilitarian and support buildings will be demolished following documentation. Residential buildings will be reviewed for feasibility of rehabilitation as housing units in a relocated clustered core "historic district." Historic landscaping will be retained in this area. (Introduced and invasive plant species will be removed on the rest of the site.)

Finally, the radio towers will be removed. The Navy's concerns over maintenance and liability were obstacles which proved to be too much to overcome during the year of discussions. SOHO suggested that these structures, if they must be lost, be interpreted in their monumentality. So one tower base, to its first horizontal section, will be retained in situ, and other components including the triatic array will be retained, incorporated and interpreted in the development.

While the integrity of this most significant site will be compromised by the development of Navy housing here, SOHO's involvement has insured that some important element of identity and memory will remain for future generations.

Robert Broms, a member of SOHO's preservation action committee, added immeasurably to the credibility of our organization with his advocacy, research and communication as SOHO's principle representative in MOA negotiations.
