## **Sherman Heights Plan Approved**

The San Diego City Council recently adopted a plan that will serve as the foundation for the revitalization of Sherman Heights, the historic district located just to the east of Centre City and an area which represents some of the earliest residential development associated with Alonzo Horton's "New Town."

Residents had eagerly awaited such a plan since the neighborhood first was designated as a historic district in 1987. Earlier action by the council had assured that the community would retain access to the Mills Act property tax incentives for historic sites, a program which is restricted in other redevelopment areas. (Sherman Heights is in a so-called "study area.")

Already, construction has begun on new "historic style" street lighting, and restoration of the 1913 landmark church owned by the Chicano Federation will soon begin.

The revitalization plan grew from several large meetings held in the neighborhood and the coordinated efforts of community activists, preservationists, civic institutions and city staff.

Deputy Mayor Juan Vargas and his staff also played a large role in bringing the plan to fruition as a "Livable Neighborhood" model.

## Measure to Provide Tax Break

A measure working its way through Congress would create a historic rehabilitation tax credit for historic structures occupied by the taxpayer as his or her principal residence. If enacted, the bill could be of significant benefit to some SOHO members.

Labeled H.R. 1662, the measure would:

- o expand home ownership opportunities for low and middle income individuals and families;
- stimulate the revival of decaying neighborhoods and communities:
- o enlarge and stabilize the tax base of inner cities and small towns; and,
- o preserve and protect our invaluable historic resources.

## Provisions of H.R. 1662

#### Rate of Credit

#### **Eligible Buildings**

The rate of credit is 20% of the qualified rehabilitation expenditures (same as the current credit). Eligible buildings are those "certified historic structures" currently eligible for the existing tax credit plus buildings individually listed on state or local register

that have been nationally certified. Eligible buildings (or a portion) must be owned and occupied by the taxpayer as his or her principal residence. Condominiums and cooperatives would be eligible.

#### **Maximum Credit**

#### **Minimum Expenditures**

The maximum credit allowable would be \$50,000 for each principal residence, subject to Alternative Minimum Tax provisions. As with the current credit, rehabilitation must be substantial - the greater of \$5,000 or the adjusted basis of such building - with an exception for buildings in census tracts targeted as distressed for Mortgage Revenue Bond purposes and Enterprise and Empowerment Zones, where the minimum would be \$5,000.

At least 5 percent of the qualified rehabilitation expenditures would have to be spent on the exterior of the building.

## What a SOHO Member Thinks

Ed. note. Following is SOHO member Carol Lindemulder's response to a recent newspaper article regarding the City of San Diego looking into the purchase of downtown skyscrapers.

## A Centerpiece Structure for Downtown

Are we really going to purchase a bunch of anonymous sky-scrapers?

It would seem that in this critical time of unemployment and lowering of real estate values in California, the City of San Diego has a real opportunity to fix up what it already owns. This will put a lot more San Diegans back to work, and offer a star attraction for San Diegans and visitors alike; let's restore our magnificent Balboa Theater building in Horton Plaza.

Look at all the pluses! It is located in the center of Horton Plaza Shopping Center, hardly a real estate value likely to slip. It is located next to an enormous parking structure, making it a perfect City office building. As the City owns it and it is empty (owned for 10 years and vacant - what a waste) there will be no purchase cost and no relocations of tenants.

Restored and retrofitted, the costs will match some of the figures quoted for buying a skyscraper, (some of which also need retrofit) which will provide no special benefits to the San Diegans whose taxes will pay for it. The Balboa will provide a centerpiece of history, a place for both visitors and locals to be proud of, relate to, amidst the excitement of the Gaslamp Quarter, historic heart of our city.

The Theater could be used by the Council and CCDC (Centre City Development Corp., the City's redevelopment agency) for large public forum opportunities, where Council chambers are too small; it could also provide additional space for visiting conventioneers to assemble, on the convenient corridor of travel up Gaslamp from the Convention Center, freeing more space there.

The Theater could be leased to our own, or other theater companies needing space, thereby providing economic return. The offices above and along Fourth Avenue could become lease home for many San Diego non-profits, and city agencies, like CON-VIS and the COM-MISSION FOR ARTS AND CULTURE, which could benefit from close proximity to tourists, The broad windows along Fourth could display items from a relocated CITY STORE, as well as information about San Diego activities in a central location for the CITY INFORMATION CENTER.

A restored Balboa would bring more people into Gaslamp during the day, people as yet unfamiliar with all it has to offer, San Diegans coming down to do business with the city.

The Magnificent Balboa, with its gorgeous dome, would become a showplace where City officials would meet potential inventors in a building clearly demonstrating the City of San Diego's commitment to downtown, and its historic heart below Broadway, not just to all the anonymous skyscrapers north of that street. And, as part of a National Register District, this nationally listed historic structure will be eligible for federal, state and private funding sources for historic properties, not available to a skyscraper of no historic value.

Let's spend some funds on a centerpiece for all San Diego!



As the foundation notes, Roosevelt is recognized as one of America's greatest environmentalists. Under his leadership, the Cleveland National Forest was established as 2,000,000 acres of magnificent wilderness from which ranged from Mt. San Jacinto to the Mexican border. Over time, this irreplaceable heritage has declined in size to 650,000 acres.

The Cleveland National Forest Foundation was created for the sole purpose of protecting what remains of the Forest. The 2,600-acre Rancho Samataguma borders on the Cleveland National Forest. The name, some say, was derived from the Indian word meaning "Valley of Water."

Nestled in its own valley and surrounded by oak-covered mountains, the ranch is a haven to all animals and guests. Its lakes are home to swans, geese, and ducks. Its meadows nourish horses, llamas, sheep and buffalo, and many domestic pets belonging to the owners.

Guests at the event will be able to tour the ranch and grounds.

## Move to Eliminate Funding for National Trust Defeated

On July 13, the House of Representatives voted (281-129) against the Hutchinson Amendment to eliminate all funding for the National Trust for Historic Preservation in the 1996 Interior Appropriations Bill (H.R. 1977).

Rep. Bob Filner was the only member of the San Diego Congressional delegation to show his support of historic preservation by voting against the Amendment which, had it passed, could have dealt a severe blow to National Trust projects and activities. SOHO thanks Rep. Filner.

## The National Register

Few issues are the source of more confusion and concern among property owners than the restriction (or lack of them) that result from listing in the National Register of Historic Places.

The Register is the federal government's official list of properties worthy of preservation. The List is maintained by the National Park Service in Washington. More than 800,000 properties are included in the Register; most are buildings, but ships, trains, bridges, and archaeological sites area also included.

Listing in the Register does not mean a property must be preserved or guarantee that it will be preserved; it simply means that the property is significant and should be preserved. (A ongoing bit of information from the National Trust.)
