

## SOHO & the National Trust sign agreement with the Padres and the City to save historic buildings in the warehouse district

This goes under the "they said it couldn't be done" category: SOHO and the National Trust for Historic Preservation have been meeting with the Padres development team for about five months now (since before the National Trust placed the Warehouse District area on their 11 Most Endangered List), and have actually signed an agreement on September 16 that will save more of the historic buildings in the project area than the City and the Padres initially thought possible.

Why have these talks? Because if SOHO didn't initiate this dialogue, then we would have had no ability to influence the City and the Padres on how historic preservation would help and enhance this project, not impede it.

Plans are being made NOW for what will happen after the City Council votes to approve the final Supplemental Environmental Impact Report and gives the go ahead to the project. (October 5 at 10 A.M. is the public hearing for comments to the City Council, and October 26 at 10 A.M. is when the City Council will vote.) While it is possible that the City Council will vote for a site that is not in the East Village, it is not probable.

If this stadium and redevelopment go in the East Village, the Padres have made it clear that they do not wish to move the stadium over two blocks east. Not only that, the SOHO members who live in the older historic neighborhoods to the east (Sherman Heights, Grant Hill, Golden Hill, Logan Heights, and Memorial) have expressed concern that any location pushing the project east pushes any traffic, parking and congestion issues further into those historic districts.

No site is without impacts. Prior to this agreement, the impacts to the historic properties in the East Village were going to be severe. Now, thanks to the incredible amount of effort by SOHO President Bruce Coons, past SOHO President

and current boardmember David Swarens, and attorney and SOHO board member Maureen Steiner, as well as Courtney Damkroger from the Western Regional Office of the National Trust, we have come to an agreement on how these historic buildings will be saved and treated.

This is the best possible outcome for these buildings and is beyond our expectations. We've achieved a new benchmark. The bar has been raised with this agreement, and it can serve as a model for future projects with the City and other developers. Most of the historic buildings are saved, and only one historically designated building is lost (the SDG&E Service Building).

#### PRESIDENT'S MESSAGE

#### A PUBLIC SERVICE MESSAGE

RECENT EVENTS IN OUR HISTORY HAVE BROUGHT HOME TO me certain thoughts about Americans and our relationship with our government, public service and responsibility for the way things are and the way this country will or could and should be in the future.

No matter what you think of the politics of the Kennedy family, you have to admire their sense of commitment to public service, the sense that they must give something back to the country, and their realization that they can and must work to improve the prospects for the country and its people.

It seems to me that we are waiting for someone to save us, to save the country, to make us feel better about our government. But it is we that must do this work. We must make our country a better place to live in. We must do this for ourselves and for the proverbial generations yet unborn. We must save

ourselves.

Your hardworking board of directors greatly appreciates comments we receive from all of you concerned with historic preservation. Comments like "thank you for what you are doing" and "people in the future will appreciate the work you are doing" and "keep up the good work" go a long way. We are spread very thin and not able to effectively meet all the challenges before us, and we really need your participation in any way you can:

- •join the SOHO board (there's an application enclosed with this newsletter);
- •help fund programs like our revolving preservation fund;
- •make your voice heard. Let people know that historic preservation is important to you.

Preserving our country's architectural heritage, history and culture for the future is one great thing "you can do for your country," your state, your country, your city, and your home. It depends on you; no one else can do it for us. If we truly participate in shaping this country, I'm sure we will all achieve something to be immensely proud of. I think this is the message JFK, Jr. and his family were hoping to convey. Presidential candidate John F. Kennedy, with Jackie pregnant with their second child at the time, was asked if he would want his son, if he had one, to enter politics. He said yes, and if they had a girl, she should also. JFK said, "I would hope they would take some responsibility for what went on." That child was a boy.•

## Historical Site Board says "not historic": Barber house destroyed

SOHO FIGHTS THE GOOD PRESERVATION FIGHT EVERY DAY. WE KNOW that we can't win them all, even if they are all important and deserving of protection as a historic resource. But the loss of the Barber House, a Hebbard & Gill design at the corner of 1st and Robinson, is particularly upsetting since the Historic Site Board voted 7 to 2 <u>FOR</u> historic designation. Eight votes were needed for the Barber House to be deemed historic, even if only nine board members are present out of the 15 members.

In March, you'll remember that the owners were mistakenly issued a demolition permit without the property going through Historic Site Board review. SOHO members alerted the city to the mistake, and the city stopped the demolition. You've heard the one about the guy who kills his parents, then throws himself on the mercy of the court because he's an orphan? Well, that's what the Site Board heard from the owners, that the building was in horrible shape and a danger to the community. However, the property was owned by the same

family for DECADES, so if the condition was as bad as they say, why wasn't this building maintained, especially since it was filled with rent-paying tenants up to a short time ago?

There were many Site Board members who argued strongly that the Barber House is important, and that the owners could retain the historic resource AND develop on their land. Heck, one board member has developed his historic properties very successfully in the Gaslamp. But two of the attending Site Board members voted "no," so the next day a demolition permit was requested and granted for the Barber House.

The city should be ashamed of this Site Board loophole of 8 votes needed, no mater how many board members are present. The mayor appoints the board members, and several of those members are very pro-new development. Too bad that due to board member absenteeism, the vote was one shy for historic designation. We all lost on this one.

In April Christine Kehoe's office promised historic preservation support for issues in her district if the Ginty House was moved. No one from her office was there to state her position for the Barber House. Hopefully, one of her reps will be there for the Mrs. Grant House on September 23 (see page 7).

## "Walls Can Talk" Workshop on October 2

WITH THE RESPONSE FROM THE OLD HOUSE FAIR OF JUNE 12 AND THE REQUESTS FROM FOLKS ATTENDING several lectures given by SOHO board members this summer, SOHO will bow to popular demand and repeat the "Walls Can Talk" Workshop on October 2.

Back again will be People In Preservation award winner Rurik Kallis, a preservation contractor, and SOHO President Bruce Coons, a restorer of many homes, to discuss the common home styles you'll find here in the county, how to lovingly

treat these homes to bring them back to their prime, and how to research your home (or hire a qualified historian to do that for you). Also in the workshop will be discussion on the Mills Act and how it can help reduce your property taxes. (Currently, the Mills Act is available only for those who live in the cities of San Diego, Escondido and La Mesa. See article on the Mills Act meeting for Coronado, page 5.) Just as last time, the workshop will be in The Crellin House, an 1887 Victorian Cottage in Sherman Heights Historic District, located at 651 20th Street. You'll see hands-on demonstrations of how to find your original paint colors and what materials to keep

replace and start new.

The previous "Walls Can Talk" workshop was scheduled for two hours, but went a lot longer with everyone's questions. No one wanted to leave, however, since so many home restorers have similar concerns! This workshop is the best bargain in town for owners of historic homes in need of renovation, so bring your questions and ask the experts. Remember: dress for mess!

## SOHO PROMOTES HISTORIC PRESERVATION AT THE XVII BORDER GOVERNORS' CONFERENCE IN TIJUANA


Thanks to an invitation from Kristin Aliotti, Director of the Governor's Office of California/Mexico Affairs, SOHO board members Pamela Bensoussan and I had the opportunity to personally address several Mexican officials who attended the XVII Border Governor's Conference held on September 10th in Tijuana. This Conference reunited four US and six Mexican governors from ten states that share the 2000 mile US-Mexican border. Pamela and I spoke to several delegates about various efforts being made by SOHO and Mexican academic and cultural institutions, as well as individuals and organizations who are all working together to promote historic preservation in California and Baja California.

Inspired by the words of various governors who referred to the border as a region with a shared culture and history, I discussed the need for including historic preservation more broadly in the agenda of binational issues for California and Baja California. I believe that a better understanding of the region can be achieved through preserving the cultural heritage (which dates from ancient times to the recent past) that is shared by Mexicans and Americans on both sides of the border. I also believe in the potential economic benefits brought by historic preservation.

Pamela and I also talked briefly to the governor of Baja California, Alejandro Gonzalez Alcocer; Federal Deputy Jaime Martinez Veloz; Municipal President of Tecate, Constantino Leon; Municipal President of Ensenada, Daniel Quintero Peña; and to the Under-Secretary of the State Ministry of Tourism, Jose de Jesus Quiñones, about the preservation projects and recent activities sponsored by SOHO and El Colegio de la Frontera Norte, the research institution. SOHO has offered continued support, promoting cooperation in preservation through the organization of workshops, tours and conferences in Baja California. Specific projects mentioned include: efforts made by US organizations and individuals in rescuing the SS Catalina currently semi-submerged in Ensenada; SOHO's interest in the protection and restoration of Tecate's railway depot; the necessity of re-opening tunnel number 3 of the Tijuana and Tecate railroad in order to promote binational tourism; and support for the historic reconstruction of Tijuana's ex-municipal palace, designed by the Quayle Brothers, noted San Diego architects.

I look forward to continuing the dialogue in the near future, expressing hope that binational cooperation in historic preservation will get wider attention as a vehicle to promote better understanding of California and Baja California's common history and to foster regional economic development and environmental quality in our region.

SOHO hopes to do more with our neighbors south of the border to help establish historic preservation guidelines, especially in Tijuana.•

It's cemetery tour time again!



See how even in death, ethnicity, status and rank are displayed at Mt. Hope. Learn why the graves of Civil War veterans are where they are, and what that cannon means. See where the gravemarkers were tossed when another cemetery was abandoned to make room for a park in Mission Hills. Check where the beautiful Irving Gill-designed monument "used to be." (Irving Gill buildings can't even get respect in the graveyard!)

Our group will meet on Halloween Day, Sunday, October 31, at 1:00, right past the Mt. Hope Cemetery entrance (inside

the gates). Wear good walking shoes for this approximately two hour tour, and remember that the dead don't need restrooms, so you won't find facilities easily available on the grounds. ## Coronado to host Mills Act workshop on September 29

IF YOU'RE A HISTORIC PROPERTY OWNER interested in what the Mills Act can do for you, get yourself to the Coronado City Council chambers, 1825 Strand Way, Coronado on Wednesday, September 29 at 7:00 P.M. for a workshop about Mills Act responsibilities

and benefits. The workshop will be conducted by Craig Rustad from the Coronado City Assessors Office, with other guest speakers.

Unfortunately, right now, only the cities of San Diego, La Mesa and Escondido have instituted this program. Many other cities within the county, when approached by concerned taxpayers who would like to take advantage of this state law, are told that the municipality just doesn't have the manpower to institute it, or they just don't think there are enough historic homes in the

region to make the paperwork worthwhile. Nonsense! San Diego County could become a model of historic preservation via reinvestment of funds formerly going to property taxes back into the historic home.

FYI -- If you live in a historic home in the city of San Diego, deadline for your application is SEPTEMBER 30 for the Mills Act to go into effect in 2000. Don't delay in calling the Historical Site board or responsible organization in your town for your application now.• OHO REFLECTIONS SEPTEMBER 1999

## Broken Promises: Ginty House Update

THE BARBER HOUSE WAS DEMOLISHED. THE Mrs. Ulysses S. Grant House is coming up for historic property review on September 23. The Ginty House...

Ah, the Ginty House has not been treated with the respect promised at the San Diego City Council meeting in April. The house was moved to it's new site. where it sat under-supported on steel bars for several months (you could stand in front and literally watch the porch sag and the plaster falling from the ceilings). During the move, many of the original glass windows (the kind where you can see the ripples) broke due to lack of support. The construction fence around the property didn't actually go all around the property, so graffiti vandals used the back and side of the Ginty for their canvas. A friend of SOHO visiting from San Francisco saw the Ginty and couldn't help exclaiming in disbelief, "this is how you treat such an amazing Victorian here in San Diego?" Yes, this is how we treat them.

In August, a meeting with a representative from Forrest City Developers. the development firm responsible for the new development on the original site of the Ginty, and with Jeffrey Tom from Christine Kehoe's council office, proved unsettling. Not only was a representative from Forrest City not available in April to be at that City Council meeting to hear what SOHO was promised, but now that the deal is done, no one wants to deal with those pesky people concerned with San Diego's architectural heritage. Forrest City's rep stated at the meeting that they do not plan a restoration of the Ginty House as promised at the City Council meeting (using Department of the Interior guidelines), but they will paint the Ginty (without documenting any evidence of historic colors, ghost outlines and other evidence of missing elements), hook up the utilities, and call it "done." SOHO offered to provide pro bono consultation on this project to see that the house is restored properly. To date, that offer has not been accept-

ed, although it's still on the table.

Understandably, Forrest City is not in the historic building restoration business and this condition was put upon the project by Christine Kehoe. According to Christine Kehoe's April 13 reply letters to all who voiced a complaint at a possible Ginty House move, "you will be pleased to know that I added an amendment to the permit that would require COMPLETE RENOVATION of the Ginty House before any of the new construction could be occupied. This will guarantee the renovation of the Ginty House." (Capitalization by SOHO.) I guess by complete renovation they mean a coat of paint, a plywood foundation, and sewer and electric hook up.

SOHO president Bruce Coons and his wife Alana have made no secret about their love of the house and their multi-year efforts to buy the house from the previous owner. This is the last, best Victorian of its kind in downtown San Diego, and as lifelong preservationists Bruce and Alana care to see the house purchased by owners sensitive to it's history and detail. For a private owner, it will take deep pockets to restore the property. For Forrest City, who received millions of dollars from CCDC to do this redevelopment project, the cost is part of doing business. It will be a great loss if the house is stripped down to the bare elements

and used as some kind of rehab or halfway house, as formerly proposed, instead of being a showplace that could rival the Villa Montezuma for interior craftsmanship and beauty.

The Ginty House is not yet for sale. When it goes on the market, we'll let you know. Anyone out there ready to bid on this important piece of San Diego's boomtown history in order to restore it correctly? Bruce Coons offers his consulting services to anyone wiling to do right by this historic property. We'll keep you posted on this situation. (For additional reading, see the San Diego Reader

All SOHO members are invited to the beautiful Greg Rogers house in Chula Vista, home of SOHO board member Pamela Bensoussan, for our annual pot luck dinner and induction of new board members. The Greg Rogers house is a very large Craftsman style home that was named "Bay Breeze" by Greg and his wife Rose. The Rogers came from Pittsburgh and decided to settle in Chula Vista after vacationing at the Hotel del Coronado.

Greg Rogers was a banker, a civic leader, and was on the first city council for Chula Vista (he's considered one of the founding fathers of Chula Vista). His 5700 square foot home was built close to the bay on E Street, but that's not where you'll find it now. In 1986 it was saved from demolition and moved to it's current location at 616 Second Avenue. It sits at the back of the property, behind the Nadine Davies Bungalow.

Although no house seems ever fully restored, the Greg Rogers house has had quite a bit of restoration work done. All the woodwork is being restored and restained, and authentic colors are being added to the walls and the maple floors. Some period hardware and lighting has been installed. The house is a wonderful setting for Pamela's collection of antiques, many of which she acquired from 10 years of living in Paris! If you like old homes, this one will really be a treat.

All SOHO members (and their preservation-minded friends) are invited to attend. Please bring a dish to share



You'll see the Nadine Davies House (the little bungalow) first. Go to the back of the driveway to enter the Greg Rogers party location. (You'll see the SOHO signs.)

ed, it is likely that a demo permit will be sought, and we'll have a repeat of what happened to the Barber House.

Why is Julia Dent Grant special, besides being the wife of the President of the U.S.? Julia was an extraordinary woman who traveled with General Grant to the battlefield with young Jesse in tow. She kept all of her husband's possessions from the Civil War and his presidency in the library upstairs. William S. Hebbard designed the house,

and it was one of the most significant homes in San Diego.

Show your support. Don't watch San Diego's history come down around you. Drop a note to SOHO that we will forward to the Site Board and Christine Kehoe's office. Let's not let what happened to the Barber House happen here.

THAT'S LEAGUES AWAY FROM WHERE THE PLAN WAS IN THE DRAFT SEIR. SOHO is very pleased with this agreement, and can now say that the historic preservation part of the ballpark and redevelopment is something that we can support.

These meetings with the Padres and the City were no love fest.

But the Padres development team wants to create a great environment for baseball and to enhance each visitor's experience to this new stadium. They want to be heroes, not hated. Both sides listened to each other. And now, with regard to historic preservation, we feel good about the way the historic properties will be retained if and when the City Council votes to go forward.

Smart people listen to ideas that will help them get what

they want. SOHO and the National Trust were able to get many ideas considered that initially

seemed impossible. So now the Candy Factory will be moved, not destroyed. The Western Metals building, which consultants said would have problems being adapted, will be adapted. And the wonderful SDG&E Station A building that was taken down a few years ago will be rebuilt and incorporated. (See the next page for a full list of what the agreement will do.) The extra cost for historic preservation measures will be paid for by the Padres, not by the City (i.e., not with our tax dollars).

Realize that SOHO's talks with the Padres about historic preservation have nothing to do with all the other issues that face this project. Everyone else with issues regarding the SEIR should continue their own discussions with the City and the Padres about those issues. Nor does SOHO's talks mean we "negotiated" regarding the sale or eminent domain acquisition of any buildings. This agreement just means that when the City and the Padres come to a resolution with all the other parties involved, the historic resources in the Padres project area will be treated in the agreed-upon pro-preservation manner.

This agreement is only for this project area; it does not extend further into the East Village. SOHO wants to work with the City and CCDC to make sure that other historic properties are retained and respected, like the wonderfully-preserved Palms Hotel (originally the Bay View Hotel) at the corner of 12th and Island and the Victorian commercial block on Market Street between 14th and 15th. These should be restored for use well into the next century.

Some people may believe that SOHO should have held out and put pressure on the City Council to vote for placing this stadium outside the East Village. To those who feel that way, your Board of Directors can only say that we work hard to SAVE HISTORIC BUILDINGS. We can't save historic buildings if we look at developers as "the enemy" and refuse to talk to them. We want to speak with developers and educate them on ways to use, reuse and adapt older, character-defining buildings. We want developers to understand that they can make more money in the long run by creating a unique project that uses a historic resource, instead of taking a scorched earth policy. The Padres development team saw how historic preservation could benefit the project. We invite other developers to CALL SOHO so we can work with you to

preserve yesterday's structures in today's redevelopment project. This can be the proverbial "winwin" situation for both sides.

For the record, neither SOHO nor the National Trust receive any funding of any kind by signing this agreement, nor any promise of any future financial support. We have not been "paid" to sign this; we have worked hard with the Padres and the City to achieve this agreement! This is a great victory for historic preservation, not

for our coffers. It is our hope that we've turned some Padres fans into historic preservation fans,

and they'll naturally want to become SOHO members!

Congrats to all on the preservation team for reaching this historic accord.

### MAJOR ELEMENTS OF THE AGREEMENT

- Extensive design criteria adopted for the new infill construction compatible with the existing structures. (Design guidelines sensitive to the historic buildings will be followed to allow new construction to be sympathetic to the old.)
- For each of the historic buildings, individual treatment plans now exist that meet the Secretary of the Interior standards for rehabilitation.
- Preservation advisory group to oversee project until completion. Group to include 3 SOHO members, 1 National Trust member, an additional preservationist elected by SOHO and the Trust, a Historical Site Board member, plus 1 member each from CCDC, the City, the Padres, JMI and Burnham Real Estate Services.
- Padres to fund Historic Survey of the area and nominate district to national, state and local registers.
- Padres to create two permanent interpretive displays within the ballpark area to show the history of the district and the history of baseball in San Diego.

#### SUMMARY: COMPREHENSIVE HISTORIC RESOURCES PRESERVATION PLAN

#### **WESTERN METAL SUPPLY COMPANY**

**Before Agreement:** the building would be little more than a facade.

After Agreement: adaptive reuse on site as retail, entries to the ballpark, Hall of Fame, Padres' Store, suites, restaurant and rooftop dining. All the historic elements preserved inside, including the old growth redwood timbers and details like the package shoots, message tubes, the safe, the original offices, the fire doors, the elevator and cash registers.

#### LEVI WHOLESALE GROCERY BUILDING (KVASS CONSTRUCTION)


Before Agreement: was to be demolished and part of the facade replicated 4' to 6' up in the air above a raised street.

After Agreement: Incorporated into park area as mixed use retail. The front and north return are preserved in place. The back will be removed to created underground parking, then rebuilt. Details like stencilled beams to be preserved in place.

#### SHOWLEY BROTHERS CANDY FACTORY

Before Agreement: was to be demolished.

After Agreement: Relocated, restored and incorporated into the park for a mixed use project of retail and office.

#### SCHIEFFER & SONS WAREHOUSE (BUNDY LOFTS)

Before Agreement: two facade used from building.

After Agreement: Will remain in place for adaptive reuse for retail and office as part of the mixed use in the park.

#### SIMON LEVIN LOFTS

Before Agreement: threatened by ancillary development. After Agreement: Building will remain in place, as is.

#### **JULIAN LOFTS**

Before Agreement: threatened by ancillary development. After Agreement: Building will remain as is.

#### **FIRE STATION #4**

**Before Agreement:** threatened by ancillary development. **After Agreement:** Building will remain as is.

#### **WELLMAN PECK WAREHOUSE (TR PRODUCE BUILDING)**

**Before Agreement:** threatened by ancillary development. **After Agreement:** This building, already owned by the Padres, will have an addition above the original rooftop to build lofts. The original building will be adapted for retail.

#### REINCARNATION BUILDING

**Before Agreement:** Building will remain as is. **After Agreement:** Same.

#### **SDG&E STATION A**

**Before Agreement:** building no longer exists (was taken down several years ago and two facades stored). **After Agreement:** It will be rebuilt within the project area.

#### **SDG&E TRANSFORMER POLE**

**Before Agreement:** [What's this weird thing? The last remaining evidence of how the city got power delivered!]Removed and placed in storage.


After Agreement: Will be relocated and incorporated somewhere on the project site.

#### **SDG&E GAS SERVICE BUILDING**

**Before Agreement:** building will be demolished for stadium. **After Agreement:** same result. This is the only historically-designated building that cannot be saved and incorporated into the project.

#### **ROSARIO HALL**

Before Agreement: building not recognized and scheduled for demolition by CCDC. SOHO brought this building to the attention of the Padres early on. It had been relocated to 12 & K at the turn of the century from its original site. After Agreement: building will be moved and restored to



Station A, currently dismantled and in storage, will be restored and reused.

# Rescue attempts continue for the SS Catalina

APPROXIMATELY ONE YEAR AGO MEMBERS OF SOHO AND researchers at El Colegio de la Frontera Norte (COLEF), together with David Engholm (who headed the


Catalina Steamship fundraising organization in Oregon), began planning how to raise the initial monies needed to re-float the SS Catalina and increase public awareness of her plight. In April of this year SOHO and COLEF invited representatives of various non-profit organizations to tour the ship and a rescue coalition was quickly formed. There have been many more meetings, tours, fundraisers and workshops. The following is a brief progress report.

In July events took place in San Diego, Tijuana and Ensenada that underscored the growing bi-national efforts to save the SS Catalina. Concerned participants traveled from Oregon, Southern California and Baja California — evidence of an increasing momentum taking shape in the race to find a solution before construction of the new Ensenada cruise ship terminal gets underway.

The exciting international preservation weekend of July 9th and 10th began with a conference/dinner on board the Maritime Museum's Berkeley to celebrate the unveiling of the SS Catalina painting by Ken Marschall, internationally famous for his paintings of the Titanic. Ken was so moved by the plight of the Catalina Steamship on our first tour to Ensenada that he created a major painting of her. Two lectures followed: Ken Marschall spoke of his personal experiences with maritime preservation issues; and a lecture was given by Don Lynch, the official historian for the Titanic Historical Society, Inc. Both speakers worked on James Cameron's blockbuster film *Titanic* (filmed partially in Rosarito Beach). All proceeds raised from the sale of the limited edition prints of the painting will be donated to the rescue project.

The following morning participants gathered for a breakfast workshop before heading down to Ensenada to once again tour the ship. The group stopped briefly at the Tijuana Cultural

Center (CECUT) where Alma Delia Abrego provided a tour of the Museum of The Californias. This important new museum, not yet open to the general

public, has exhibits on regional history from pre-Hispanic to recent times of the Californias, concentrating on Baja California and Baja California Sur. It includes an interesting ship model exhibit recalling the region's maritime history.

On July 10th another celebrity personality became involved in the Catalina Rescue Project. Television personality Huell Howser of California's Gold fame joined us on the tour to Ensenada where he filmed an exciting episode for his TV show. He rushed back to his production studio where they masterfully put together his program for immediate airing. It has already been broadcast three or four times during the summer. (If you'd like to order a copy of the show, call 800-343-4727.) Huell plans to continue his coverage of the project and has become an ardent spokesperson for the ship's rescue. As a result of his immensely popular show a wide audience throughout California now knows about the SS Catalina's plight. During her time in service over 24 million people traveled on the Catalina and checks have been pouring in with poignant letters from viewers describing their memories and affection for the ship.

In August we met in Mexico with Vice-Almirante Armando Sanchez Moreno, Raul Arenas and his team from Marina Pacifica of Ensenada and Phil Thorpe, an expert marine surveyor from San Diego who is generously donating his time as technical consultant for the project. We presented a formal proposal and detailed organizational plans to the Mexican authorities who are encouraging us to continue our efforts. Also in September we participated in a workshop on bi-national preservation hosted by CECUT where we spoke on the plight of the ship to a largely Mexican audience interested in preservation. On September 10 we attended the

Governors Conference (see page 4) and lobbied for bi-national government support for the project.

Many of the individuals active on the rescue committee are now forming a separate 501-c-3 non-profit corporation. Their mission will be to "rescue, restore, and establish an appropriate long-range management plan for re-use of the historic ship...and to increase awareness of maritime history and preservation in the border region." The group has asked

other non-profit organizations -- some of whose members have already been participating -- to each nominate a representative to serve on the new board of directors. In addition to SOHO and COLEF, the nominating organizations are: The San Diego Maritime Museum; The Titanic Historical Society; Steamship Historical Society of America, Southern California Chapter; State of California Governor's Office of California/Mexican Affairs; Los Angeles Conservancy; Tijuana Cultural Center (CECUT); SS Catalina Steamship Fund; Merivale Enterprises; Mexican Ministry of Tourism; and the University of Baja California.

Now efforts are being concentrated on the search for a final destination in Southern California where the SS Catalina can be preserved as a museum ship. This project exemplifies the importance of establishing a working collaboration between Mexican and American organizations in the border region. While the ship herself does not relate much to the cultural heritage of Baja, she has enormous importance to Southern California history. Without the consideration and sensitivity of the Mexican authorities to the concerns of its neighbors in California, the ship would have been destroyed some time ago. The Catalina's position in the Ensenada harbor is perceived locally as a potential obstacle to the new cruise ship terminal whose construction will soon be underway.

Thanks to all those who have contributed so far: a message from the artist

Dear donors to the S.S. Catalina rescue effort:

I want to personally thank you for your generosity in sending a donation to help rescue the old S. S. Catalina from a sad and unnecessary fate. If it weren't for caring people such as yourself, we would have little chance of saving her from a Mexican scrap yard. Your kind contribution brings us that much closer to our goal of getting her pumped out, refloated, and safely into drydock. And that's only the first step to getting her restored and in use once again. We have a long, arduous and expensive job ahead of us.

As the artist who recently completed the painting of the S.S. Catalina from which lithographs are being printed for you and other donors, I wanted to let you know how it's going. Being a perfectionist, I continued working on the painting long after I had told everyone it would be done, and it only went to the printers in late August. With the various proofing processes, etc., I anticipate shipping your print by the middle of September.

The print shows the Catalina in late afternoon during her first season of service in the summer of 1924. Behind her, in the distance, is the small town of Avalon with its old dance pavilion and memorable "sugarloaf" rock. Much research went into determining the ship's original configuration and color scheme from information provided by historians and archivists on both the island and ashore. I couldn't have done the painting definitively without their help.

As for the current status of the ship itself, thanks to the recent airings of Huell Howser's PBS television program about her plight, we are approaching half of the \$40,000 (if we can raise it) will only get us to the very fist step. Once the ship is floating, more financing will be urgently needed to get her cleaned out, then to begin the time-consuming and expensive restoration work. The need is urgent. Please tell your friends. And if you can spare any more funds, now is the time donate. Remember, contributions are tax deductible!

The more donations received, the quicker she'll be back up here in California and on the road to the safe, successful, useful future this historic ship deserves.

Again, many thanks for your contribution to rescue the Catalina.
